Special Meeting  
City Council - Fayetteville, N. C.  
June 23, 1960

A special meeting of the City Council was held in the City Hall June 23, 1960, at 2:30 p.m.

This meeting was called for the purpose of discussing the revised proposed budget for 1960-61. On motion of Councilman Pate, seconded by Councilman Plummer, the salary of the City Manager was increased by \$300.00 per year and the salary of the City Clerk and Treasurer was increased by one pay step.

On recommendation of the City Manager and on motion of Councilman Massei, seconded by Councilman Plummer, the proposed budget for 1960-61 as revised was tentatively adopted by the City Council.

Mr. J. Bernard Stein, President of the Chamber of Commerce stated that it is going to be necessary for the streets adjacent to the property recently purchased from the city known as the McArthur property to be paved so that it can be used as industrial property, however, they have found that the State Highway Commission cannot pave Gray Street north because it is in the City and does not connect with the highway system. There is approximately 900 feet down Gray Street and approximately 300 feet on Mar Street that is necessary that they have paved and they ask that the City pave the streets for them. Mr. Stein was informed that it would be necessary for him to present a petition for paving the street signed by the property owners of the area. The matter was discussed at length and no definite action was taken at this time.

There being no further business, on motion of Councilman Plummer, seconded by Councilman Massei, the meeting was adjourned.

Regular Meeting

July 11, 1960

The regular meeting of the City Council was held in the City Hall on July 11, 1960 at 8 p.m.

Present: Mayor George B. Herndon

Mayor Herndon called a public hearing that was advertised for this time on an amendment to the zoning ordinance. There being no opposition present, on motion of Councilman Massei, seconded by Councilman Rose, the zoning ordinance was amended as follows:

Rezone from residence 5 to industrial an area lying between the east side of Robeson Street and Blounts Creek across Highway 15-A from Commerce Street.

Mr. Bob Brown requested the Council to make an appropriation on behalf of a proposed County Rescue squad. Mr. Brown stated that their total budget for the year will be approximately \$6,800.00. It was the opinion of Councilman Plummer that an organization of this kind and financed along on the same basis as the rural fire departments have been financed. Councilman Rose stated that in his own mind he cannot justify appropriating \$3,500.00 to this project when they have recently required the City Departments to reduce their budgets by a larger amount. After considerable discussion, Councilman Rose moved that the request be denied. Motion seconded by Councilman Pate, unanimously carried.

On recommendation of the Planning Board and on motion of Councilman Pate, seconded by Councilman Plummer, public hearing was set for 8 p.m. August 8th on an amendment to the zoning ordinance to rezone from local business to residence 10 an area off Owen Drive and Melrose Road involving a part of section three in the Bordeaux Subdivision.

On recommendation of the Planning Board and on motion of Councilman Pate, seconded by Councilman Rose, final approval was given the plat of Section III, Part II of Vanstory Hills.

On recommendation of the City Manager and Chief of Police and on motion of Councilman Pate, seconded by Councilman Plummer, the applications of the following men for taxi driver permits were unanimously approved:

On motion of Councilman Plummer, seconded by Councilman Pate, Mr. P. O. Hoffer was reappointed as a member of the Public Works Commission for a term of three years to expire June 1963.

On motion of Councilman Rose, seconded by Councilman Plummer, Mr. Ted Rhodes and Mr. Julian Hutaff were reappointed as members of the Airport Commission for two year terms to expire June 18, 1962.

On motion of Councilman Plummer, seconded by Councilman Pate, John Austin Williams was appointed as a member of the Recreation Advisory Commission to fill the unexpired term of C. R. Coleman who's term expires in October 1960.

On motion of Councilman Massei, seconded by Councilman Plummer, Mrs. Rudolph Singleton was unanimously reappointed for a three year term to expire 1963 as a member of the Board of Adjustment.

Motion of Councilman Pate, seconded by Councilman Massei, Mr. D. B. Maness was unanimously appointed for a three year term to expire July 1963 as a member of the Board of Adjustment.

On motion of Councilman Massei, seconded by Councilman Rose, E. E. Miller was unanimously reappointed for a three year term to expire July 1963 as a member of the Board of Adjustment.

On motion of Councilman Plummer, seconded by Councilman Massei, Carl Sloan was unanimously reappointed as a member of the Planning Board for a three year term to expire July 1963.

On motion of Councilman Massei, seconded by Councilman Plummer, Mr. Jim Thornton was reappointed as a member of the Planning Board for a three year term to expire July 1963.

On motion of Councilman Rose, seconded by Councilman Massei, Mr. Hal Broadfoot was appointed as a member of the Urban Redevelopment Commission to fill the unexpired term of Mr. Steve Nimocks which will expire in December 1960.

On request of Mr. Ray Muench, Public Works Commission, a joint meeting of the Public Works Commission and the City Council was set for 4 p.m. on Thursday to discuss the proposed budget of the Public Works Commission 1960-61.
