Mr. Roscoe Blue stated that he would like to pave the Streets of Bordeaux Subdivision and that the City share in the cost of paving for this subdivision that the prevailing unit price of the present contract if the work is done under the specifications of the City. The City Manager stated that this kind of arrangement has been made in other subdivisions. Councilman Massei moved that the request of Mr. Roscoe Blue be approved and that the City reimburse him for their share of paying of Bordeaux Subdivision according to the prevailing unit prices of the present contract. Motion seconded by Councilman Plummer, unanimously carried.

Mr. Bill Ashley, Assistant City Engineer presented plans for improving a street off Camden Road and the City Manager stated that it has never been maintained as a public street and the City has been working for approximately a year to obtain the necessary right of way. Now the necessary right of way for the street has been obtained and he recommends that it be accepted as a public street, on the condition that the property owners will provide the necessary pipe for drainage in making this a 40 foot street. Councilman Massei moved that the recommendation of the City Manager be approved and the street be accepted as part of the city streets on the conditions set out by Mr. Ray. Seconded by Councilman Rose, unanimously carried.

The City Manager read a letter from Mr. F. D. Byrd with reference to allowing the City an entrance to the property behind the Veterans Hospital that is to be developed by the city as a park. and agreeing to provide the entrance for the cost of one lot. That would be \$2,000.00. The matter was discussed and the City Manager was requested to make further check with Mr. Byrd to determine when the subdivision will actually be completed and make a report back to the Council at a later date.

The City Manager presented a letter from the Southern National Bank requesting that they be added to the list of depositors for the City of Fayetteville. On motion of Councilman Massei. seconded by Councilman Pate, the Southern National Bank was designated as a depositor for the City of Fayetteville.

The City Manager stated that some time ago he suggested buying City tags from the N. C. Prison Department and it was not approved because they would not put the Market House on the plate. Now it is possible for them to add the Market House and there would be a saving on the cost of each tag of approximately 4 cents. The City Manager asked for approval of the purchase of the City tags from the N. C. Prison Department. Councilman Rose moved that the City Manager be authorized to purchase the tags from the N. C. State Prison Department. Motion seconded by Councilman Plummer, unanimously carried.

The City Manager has reported that he has made some investigation and finds that it will be possible to construct the boat ramp within the figure appropriated in the present budget therefore he requested permission to advertise for bids. Councilman Pate moved that the City Manager be authorized to advertise for bids for the construction of a boat ramp on the Cape Fear River. Motion seconded by Councilman Plummer, unanimously carried.

After some discussion, Councilman Plummer moved that the City Manager be authorized to pave the property directly across the street in front of the city school to be used as a parking lot. Motion seconded by Councilman Massei, unanimously carried.

The City Manager reported that he had made investigation on several companies for the provision of uniforms for the Street and Sanitary employees. The City Manager stated that some time ago there was some discussion of uniforms for the street and sanitary department employees and before contacting the companies he would like to have some idea as to what portion of the costs the City Council would be willing to assume. Mr. Ray further stated that last year he had quotaof \$1.60 per week for the uniforms and found that it is usual for the employer to pay \$1.00 and the employee to pay 60¢. It was suggested by Councilman Plummer that the City participate in 50% of the cost, however, he does not recommend making it compulsory for the employees to rent the uniforms. The City Manager stated that he will make further investigation and report back at a later meeting.

The City Manager presented the resignation of W. H. Huggins as a member of the Police Department. Councilman Massei moved that the resignation of W. H. Huggins be approved. Motion seconded by Councilman Rose and unanimously passed.

The City Manager and Chief of Police recommended the appointment of Daniel Keith Dixon to fill the vacancy left by the resignation of W. H. Huggins in the Police Department. Councilman Plummer moved that Daniel Keith Dixon be appointed as a city policeman. Motion seconded by Councilman Massei and unanimously carried.

The City Manager reminded the members of the Council that at a previous meeting recommendation had been made to them that Mr. C. B. Foulk be promoted to the rank of Captain in the Police Department but no action has been taken to this date. Therefore, Councilman Pate moved that Mr. C. B. Foulk be promoted to the rank of Captain of the Police Department. Motion seconded by Councilman Plummer and unanimously carried.

Councilman Pate asked what procedure should be taken in order for the City of Fayetteville to have an ad in the progress edition of the Fayetteville Observer that is to be published some time in September. The matter was discussed by members of the Council but no action was taken at this

There being no further business, on motion of Councilman Rose, seconded by Councilman Massei, the meeting was adjourned.

Mayor Herndon suggested that the City should have some advertising in the Special progress edition of the Observer and since the City Council cannot spend money for such projects that the Council request the Public Works Commission to pay for it.

On recommendation of the Planning Board and on motion of Councilman Plummer, seconded by Councilman Pate the plate of a subdivision at Tokay and Kirkland Drives was unanimously approved subject to making satisfactory arrangements for utilities.

Having been duly advertised, on motion of Councilman Massei, seconded by Councilman Rose, the following ordinance was unanimously adopted:
