

On motion of Councilman Pate, seconded by Councilman Plummer, contract for two police cars and one police station wagon was awarded to LaFayette Motor Company.

On motion of Councilman Pate, seconded by Councilman Plummer, contract for car for the Inspection Department was unanimously awarded to LaFayette Motor Company.

On motion of Councilman Pate, seconded by Councilman Plummer, contract for one Utility Vehicle for the Engineering Department was unanimously awarded to M & M Truck and Tractor Company.

On motion of Councilman Plummer, seconded by Councilman Pate, the contract for one 1960 truck chassis for the Fire Department was unanimously awarded to LaFayette Motor Company for C800 model.

On motion of Councilman Plummer, seconded by Councilman Pate, the contract for one fire utility truck for the Fire Department was unanimously awarded to M & M Truck & Tractor Company.

Councilman Rose moved that two trucks for the Street and Sanitary Department be purchased from M & M Truck and Tractor Company. Motion seconded by Councilman Plummer. Voting "Aye" Councilman Rose, "nay" Councilman Plummer, Pate and Mayor Herndon.

On motion of Councilman Pate, seconded by Mayor Herndon, the contract for one truck for the Street and Sanitary Department was awarded to M & M Truck and Tractor Company and the other was awarded to Edmac Truck Sales. Voting for the motion, Councilmen Pate, Plummer and Mayor Herndon; against, Councilman Rose.

On recommendation of the City Manager and on motion of Councilman Plummer, seconded by Councilman Rose, the contract for tires and tubes for the year was unanimously awarded to Corder-Vossler Company.

On recommendation of the City Manager and on motion of Councilman Pate, seconded by Councilman Plummer the contract for recapping was unanimously awarded to Corder-Vossler Co.

On recommendation of the City Manager and on motion of Councilman Pate, seconded by Councilman Plummer, the contract for batteries was unanimously awarded to Corder-Vossler Company.

On recommendation of the City Manager and on motion of Councilman Pate, seconded by Councilman Plummer, the contract for gasoline for the year was awarded to Pure Oil whose bid in the amount of .1938 per gallon less 1% discount was low.

On recommendation of the City Manager and on motion of Councilman Pate, seconded by Councilman Plummer, the contract for oil, grease and hydraulic oil was unanimously awarded to Pure Oil Company.

On recommendation of the City Manager and on motion of Councilman Plummer, seconded by Councilman Pate, the contract for anti-freeze was awarded to Arkansas Fuel Oil Company.

On recommendation of the City Manager and on motion of Councilman Plummer, seconded by Councilman Rose, the contract for Diesel Oil was unanimously awarded to the Texas Company.

On recommendation of the City Manager and on motion of Councilman Pate, seconded by Councilman Rose, the contract for #2 Fuel Oil was unanimously awarded to the Pure Oil Company.

On recommendation of the Planning Board and on motion of Councilman Pate, seconded by Councilman Plummer, public hearing was set for 8:00 P.M., September 12, 1960, and an amendment to the Zoning Ordinance to Rezone from R-10 to Local Business the following described property:

BEGINNING at a point which is 10 feet to the west of the western margin of Emeline Avenue and 375.11' north of the northern margin of Raeford Road and running thence south 85 degrees 56.6 minutes west 277.82 feet to a point in the eastern margin of a proposed street; thence with the eastern margin of the proposed street N. 4 degrees 3.5 minutes E. 5' to a point; thence N. 85 degrees 56.6 minutes E. 277.92 feet to a point; thence S. 4 degrees 3.5 minutes E. 5' to the beginning and being a 5' strip of land adjacent to a portion of the Tally property which was rezoned to local business on January 11, 1960.

Such rezoning to continue so long as the applicants maintain a five foot planting or screening strip adjacent to and to the north of the area requested to be rezoned in accordance with the agreement stated in the application bearing the signatures of J. O. Tally and Mary E. Tally said agreement being in the files of the City Planning Board.

On recommendation of the Planning Board, and on motion of Councilman Pate, seconded by Councilman Plummer, plat of revision of Lots 21-30 subdivision owned by Mrs. E. B. Monaghan was unanimously approved.

On recommendation of the Planning Board and on motion of Councilman Pate, seconded by Councilman Plummer, the plat of Edgewood Drive, Section 2 was unanimously approved subject to the approval of the Public Works Commission and the Engineering Department.

Mr. Al Rumbough, Planning Director, presented to each member of the Council a copy of the Economy Report for the City of Fayetteville that was prepared by his Department.


The City Manager reported that on November 8, 1950, leave of absence was granted to Raymond Jones of the Police Department to serve in the armed forces. This man was drafted and at the end of that tour of duty he re-enlisted for two more tours. He is now out of the service and has requested that he be allowed to return to work. The matter was discussed and Councilman Pate moved that in view of the fact that the leave of absence was for one tour of duty, he be denied reinstatement unless he can qualify through examination. Motion seconded by Councilman Rose and unanimously carried.

The City Manager read a letter from Hunter Brothers asking that six spaces in front of their business on Winslow Street be changed to 36 minute meters. Councilman Plummer moved that the request be denied. Motion seconded by Councilman Pate and unanimously carried.

On recommendation of the City Manager and the Chief of Police and motion of Councilman Plummer, seconded by Councilman Pate, the application of Wilbert Sports for a taxi driver's permit was unanimously approved.

The City Manager reported the resignation of Jessup T. Melvin from the Police Department. Councilman Pate moved that the resignation be accepted. Motion seconded by Councilman Plummer and unanimously carried.

There being no further business, on motion of Councilman Plummer, seconded by Councilman Rose, the meeting was adjourned.
