The regular meeting of the City Council was held in the City Hall at 8:00 P.M. on December 12, 1960.

Public hearing having been duly advertised and there being no opposition present, a motion by councilman Rose, seconded by Councilman Plummer, the following amendment to the zoning ordinance was unanimously approved:

Rezone from Residence 5 to Industrial the property beginning at a point on the northern margin of Tolar St. said point being 520.78 from the western margin of Southern Avenue; and running thence north 47 degrees east approximately 140' to the center line of the Aberdeen and Rockfish Railroad survey of the present industrial district and running thence with the center line of the Aberdeen-Rockfish Railroad and the present industrial district boundary in a northwesterly direction approximately 180 feet to a corner in the present industrial district boundary; and running thence with the present industrial district line in a southwesterly direction approximately 115 feet to a point where the present industrial district intersects with the northern margin of Tolar Street; and running thence with the northern margin of Tolar Street in a southeasterly direction approximately 180 feet to the point of beginning; and being the southeastern corner of a tract of land belonging to Harold K. Cohen, and wife, as shown in map book #9 page 21 register of deeds Cumberland County.

At the meeting of City Council on August 8, 1960, action was deferred on a request for rezoning property owned by Dr. Godwin on Melrose Avenue so a professional building could be erected on this land. This action was deferred to give the Planning Board an opportunity to prepare a new zoning ordinance which was proposed to include a zone P-1 that would be for Professional Buildings. Mr. Carl Barrington, Attorney representing some of the people of this area presented a petition at an earlier meeting requesting this property be rezoned to residence 10. Mr. Barrington stated at this time that his client would be willing to wait the extra time that it might take for preparing the proposed zoning ordinance, however, Dr. Godwin stated that he has waited four months for a decision and he would like some action to be taken. Under the present zoning in this area Dr. Godwin would be permitted to proceed with his plans for a profession building, therefore, Councilman Rose moved that the petition to rezone his property as R-10 be denied. Motion seconded by Councilman Plummer and unanimously carried.

On motion of Councilman Plummer seconded by Councilman Rose the following ordinance was unanimously adopted:

AN ORDINANCE CONFIRMING THE ASSESSMENT ROLL FOR THE PAVING AND OTHER
IMPROVEMENT OF EATON STREET, ORANGE STREET AND STONEWALL AVENUE

After careful study and consideration of the matter and of all pertinent facts and circumstances, and in the exercise of its best legislative judgment, the City Council of Fayetteville, North Carolina, finds as fact that:
