

relaying, or repairing of any necessary municipally-owned electric lines, water, sewer, gas or other pipelines or conduits; together with all necessary house or lot connections or services extending to the outer edge of said project, whether made necessary by the widening of existing or construction of new or relocated streets or sidewalks.

- (4) Establishing and maintaining traffic operating controls for the regulation of movement of traffic on said project.

NOW, THEREFORE, BE IT RESOLVED that the said Project 8.13373, Cumberland County, be and it is hereby formally approved by the City Council of the Municipality of Fayetteville and that the Mayor and Clerk of said Municipality be and they are hereby empowered to sign and execute the required Agreement between this Municipality and the State Highway Commission.

The City Council and the County Commission met in a joint session with officials of the City-County Office of Civil Defense this date to discuss a Civil Defense matter.

Mayor Butler presented a brief resume' of the subject - the establishment of emergency headquarters for the Office of Civil Defense in the event of an emergency in the basement quarters of the City Hall and then called On Col. Larsen for a report.

Col. Larsen presented a report on activities of the Office of Civil Defense and stated that in order to prepare the headquarters for use it would be necessary to have installed a propane gas tank, a water tank, radiation shielding and sleeping quarters for personnel manning the stations. Col. Larsen stated further that the cost of such installations would be \$1,690.00 and requested an appropriation from the City and County for this purpose.

Following a brief discussion, City Councilman Rhodes moved that the City agree to pay it's proportionate share, which would be one half. Councilman Rose seconded the motion and it carried.

County Commissioner Blue then moved that the County agree to pay it's proportionate share, which would be one half. Commissioner Beard seconded the motion and it carried.

Col. Larsen then presented for signature an agreement from the Federal Government whereby the City Hall would be officially designated as a public shelter in event of an emergency. Mayor Butler and the City Clerk, executed the agreement for the City.

There being no further business by the City Council with the County Commission, the Council excused itself from the joint session at 11:00 A. M.
