Councilman Rhodes inquired as to the status of sanitary sewer main extension on Dogwood Street. Public Works Commission Administrator Ray. A. Muench, Jr. stated that eight of the ten applications required for extension of service had been received to date and work could be scheduled as soon as remaining two applications are received.

The matter of an amendment to the City's Alcoholic Beverage Ordinance, which was presented at an earlier meeting, was again presented for discussion. Approximately fifty persons were present in opposition to the proposal.

Upon motion by Councilman Plummer, seconded by Councilman Rhodes the Council voted to take no action on the amendment.

The Washington Drive Parent-Teachers Association, headed by William H. Carver, spokesman for the group, was recognized by the Council for a hearing on the question of paving a sidewalk along their street.

(This matter was before the Council approximately two years ago and the interested parties were requested to get a petition for the sidewalk signed by the abutting property owners. Less than forty (40) per cent of the abutting frontage, including the city schools portion, was signed in favor of the project)

Mayor Butler read a letter from Mr. C. Reid Ross, Superintendent of City Schools, in which he stated for the Board of Education, their approval of the sidewalk paving.

Since the petition presented by the group did not represent a majority, they were advised to contact the City Engineer to secure the necessary petition and present it at a later meeting after securing the required number of signatures.

On Planning Board matters: a public hearing was ordered, upon motion by Councilman Rose, seconded by Councilman Rhodes, Councilman Plummer voting "no", for March 12, 1962, to rezone a tract of land on Ramsey Street 60 feet Northward from Sunrise Creek from R6 Residential District to C1 Local Business.

Upon motion by Councilman Rhodes seconded by Councilman Plummer a public hearing was also ordered for March 12, 1962 to rezone a tract of land adjacent to Hay and Davis Streets and Arsenal Avenue from R 5 Residential to P 1 Professional District.

Upon motion by Councilman Plummer, seconded by Councilman Rhodes, the Council authorized the Mayor and City Clerk to sign an agreement with the Division of Community Planning, Department of Conservation and Development to obtain a \$45,000.00 federal grant for Urban Planning Assistance.

In connection with the above; the Council, upon motion by Councilman Rhodes, seconded by Councilman Plummer, adopted a resolution granting the Planning Director authority to enter into a contract with the Department of Conservation and Development for Urban Planning Assistance upon approval of above application agreement.

Mrs. Marion Szymkowicz was recognized on a rezoning matter. (A public hearing was held on this matter on January 8, 1962 and Council voted to deny the rezoning request since objections were raised)

Mrs. Szymkowicz stated that since she was unable to be at the meeting of January 8, 1962, she would like another opportunity to present her request for rezoning.

After a brief discussion, the Council, upon motion by Councilman Rose, seconded by Councilman Plummer, voted to rescind its action of January 8, 1962, and advertise a public hearing for March 12, 1962.

On taxicab driver permit applications; the Council, upon motion by Councilman Plummer, seconded by Councilman Rose approved the following applications:

Marcus Paul Lintner and William Bowersox

The Council heard a request from Mr. H. B. Cashwell to secure two additional taxicab operator permits from the widow of Mr. John K. McCaskill. After discussion of the matter, Councilman Plummer moved that the request be tabled until the next regular Council meeting. The motion was seconded by Councilman Rose and Approved.

Upon motion by Councilman Plummer, seconded by Councilman Rose, the Council voted to participate to the City's usual extent jointly with a Mr. S. S. Woodall in the installation of a storm drain on Bragg Blvd. in the vicinity of Jackson Avenue.

Upon motion by Councilman Plummer, seconded by Councilman Rhodes, the Council accepted the low bid for three police cars made by Bryan Pontiac-Cadillac Company for \$9,299.34. Three used cars will be traded in.

Council heard a request by Mr. J. T. Riddle, President of Vimar, Inc. to be authorized to pave, under private contract, in Stratford Hills Subdivision. Councilman Rhodes moved to grant authorization as requested. The motion was seconded by Councilman Plummer and carried.

Councilman Rose moved that a vacant lot at the south end of Wiesiger Street be purchased by the city from Robert and Alma Hughes for \$400.00. Motion was seconded by Councilman Plummer and carried.

Upon motion by Councilman Plummer, seconded by Councilman Rose, the resignation of Fred E. Hames from the Police Department was accepted by the Council.

City Manager G. W. Ray, read a letter to the Council from Mr. J. W. Spruill, Division Engineer, State Highway Commission could not offer any assistance in the drainage problem of Mrs. Elizabeth Henderson, Murchison Road, discussed at an earlier Council meeting.

No action was taken on a request by a Mr. Willis for a taxicab operators permit.

Mr. Ray, City Manager, presented sketches for the remodeling of the Police Assembly Room. He stated the cost would be approximately \$7,000.00.

Upon motion by Councilman Rhodes, seconded by Councilman Rose, the Council voted to proceed with the alterations.

Mr. Bill Ashley, City Engineering Department, reported to the Council that the approximate cost for drainage at State Teachers College would be \$42,727.00 and for sidewalks, \$4,100.00.

Mr. Ray was requested to write Dr. Jones of the college to this effect.

City Attorney, Tally, asked the Council if the Tax Collector showed rescind tax assessment to Powell Tabernacle Baptist Church in view of a deed made to the City by Mr. Powell for some property at this location some years ago.

It was decided to review the minutes on the matter before a decision was made.

The following resolution was adopted by the Council at its regular meeting of January 8, 1962:

And based further upon the Report on the Cape Fear River Basin issued 30 October 1961 by the Corps of Engineers, U. S. Army;

And based further upon our reasonable expectations and our informed study of the possibilities for the future, if the development of this Basin is carried out pursuant to the report of the Corps of Engineers;
