The purpose of this special meeting of the City Council was for further discussion of the preliminary budget for the City for 1962-1963.

First items receiving deliberation were the proposed budgets for the Police and Fire Departments with special attention being given to salary considerations. Chief of Police Worrell was present and answered inquiries directed at him by the Council concerning his budget. Fire Chief Cain was also present and answered inquiries.

Chief Cain also reported to the Council on the progress being made on the new addition being made to Fire Station No. 2 to house the radio and fire alarm equipment. He also stated that an additional amount of \$6,939.00 would be needed for the following items:

Councilman Rhodes moved that the additional appropriation of \$6,939.00 be authorized to complete the above work. Motion was seconded by Councilman Plummer and carried.

Chief Cain also reported on the progress being made on Fire Station No. 5.

There then followed a thorough examination and discussion of all phases of the 1962-1963 budget.

Following this, Councilman Maness moved for tentative adoption of the preliminary budget for the Fiscal Year 1962-1963. Motion was seconded by Councilman Plummer and carried unanimously.

During the discussion, it was decided by the Council to delete the following items and/or amounts from the proposed 1962-1963 budget.

The City Council met in regular session on this date.

A public hearing having been advertised and there being no opposition present and upon motion by Councilman Rhodes, seconded by Councilman Maness the following Ordinance was adopted unanimously:

AN ORDINANCE EXTENDING THE CITY LIMITS

WHEREAS, notice was duly published in the Fayetteville Observer, a newspaper published in the City of Fayetteville, that at the meeting of the City Council, to be held in the City Hall, at 8:00 P. M. on July 9, 1962, there would be considered the annexation to the City of all of the area hereinafter described, as directed by said Council at its regular meeting on the 11th day of June, 1962, and as petitioned for by all the owners of the property in such area;

AND WHEREAS no petition was filed or protest made against the annexation thereof to the municipality;

AND WHEREAS, it is considered in the best interest of the City of Fayetteville and its inhabitants to annex said area to and include it within the municipality;

THEREFORE, THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE DOES ORDAIN:

That in accordance with North Carolina General Statute 160-452 and related statutes, said area, contiguous to the present boundaries of the City, described below, be annexed to and made a part of the City of Fayetteville, to wit:

BEGINNING at a stake in the original line of the tract of which this is a part siad beginning point being the southwest corner of Lot 1, Block "C", "Property of Broadwell Construction" as recorded in Cumberland County, North Carolina, Registry, Plat Book 21, Page 18, and running thence with the original line North 81 degrees 37 minutes West 210.68 feet to a point in the eastern margin of Cain Road; thence with the eastern margin of Cain Road North 12 degrees 17 minutes East 170.32 feet to a stake at the intersection of the eastern margin of Cain Road and the northern margin of Woodbine Avenue; thence with the northern margin of Woodbine Avenue South 81 degrees 37 minutes East 206.29 feet to a stake, said stake being the southwest corner of Lot 6, Block "B" of "Property of Broadwell Construction"; thence with the western line of Lot 1, Block "C", South 10 degrees 47 minutes West 170.15 feet to the beginning.

And that the Mayor cause an accurate map of such annexed territory, together with a copy of this ordinance duly certified, to be recorded in the office of the Register of Deeds of Cumberland County and in the office of the Secretary of State.

This ordinance shall be in effect from and after its adoption.
