4.0 ITEMS OF BUSINESS

4.01 City of Fayetteville Redistricting Presentation

Ms. Caroline Mackie, Redistricting Consultant, presented this item and stated the City of Fayetteville uses true election districts and the districts are outside the permissible deviation range; per the results of the 2020 Census. Ms. Mackie displayed a map that showed the North Carolina population change since 2010 by tract, and stated the ideal district population is 23,167, with a range of 22,009 to 24,326. A chart was displayed showing the population of each of the nine districts. Ms. Mackie stated the governing body of the local government is responsible for enacting new districting plans every ten years. However, the General Assembly retains the power to redistrict for the board by local act. Race cannot be the predominant factor in redistricting unless the use of race is narrowly tailored to a compelling governmental interest. Ms. Mackie provided an overview of the redistricting process and the timeline for Fayetteville.

Discussion ensued.

Mr. Douglas Hewett, City Manager, stated all questions from City Council are to be sent to the City Clerk. The next meeting to discuss redistricting will be held on August 30, 2021.
