7.04 Adoption of Budget Ordinance Amendment 2022-5 (Carryover of Encumbered, Assigned and Donated Funds from Fiscal Year 2021 and Other Items) and Adoption of Related Capital Project Ordinance Amendment 2022-39 and Capital Project Ordinance 2022-15

Budget Ordinance Amendment (BOA) 2022-5 will appropriate \$7,891,088.00 across several annually budgeted funds for outstanding purchase orders and contracts at the close of fiscal year 2020-2021 (FY 21). These appropriations will primarily be funded by fund balance or net assets appropriations for the various funds.

The BOA will also appropriate \$15,319.00 for unspent donation proceeds, and \$8,860,408.00 for specific items for which funding was assigned (designated) at the close of FY 21. Funding for these expenditures was included or available in the FY 21 budget. These appropriations will primarily be funded by fund balance or net asset appropriations for the various funds; the only exception being \$128,830.00 from the Federal Emergency Management Agency (FEMA) and the State of North Carolina for 75 percent and 25 percent shares for expenditures eligible for reimbursement for hurricane related projects.

An appropriation of \$342,560.00 is included in the BOA for the Emergency Telephone System Fund to fund a generator replacement that was planned in FY 21. This appropriation will be funded through use of fund balance restricted for expenditures deemed eligible by the North Carolina 911 Board.

An appropriation of \$75,000.00 for capital maintenance expenditures for the Franklin Street Parking Deck is included for the Parking Fund to be funded by fund balance reserved for capital maintenance.

Finally, the BOA includes an increased appropriation of \$228,500.00 for the financial plan for the Risk Management Internal Service Fund to provide needed funding for unanticipated increases for property and liability insurance premiums. This appropriation is to be funded through an internal transfer from the General Fund of fund balance.

Council is also asked to adopt two capital project ordinances related to the BOA. Capital Project Ordinance Amendment 2022-39 will appropriate \$100,000.00 designated for additional concrete repairs to walkways, dugouts and shelter pads at various park locations. Capital Project Ordinance 2022-15 will appropriate \$800,000.00 designated for a Makers Space facility.

7.05 Adoption of Capital Project Ordinance 2022-14 and Capital Project Ordinance Amendments 2022-37 and 2022-38 to Appropriate North Carolina Department of Transportation Grant Funding for Three Airport Capital Improvement Projects

The North Carolina Department of Transportation's Division of Aviation has awarded \$2,123,527.00 to the City for Airport

improvements. Council is asked to adopt Capital Project Ordinance (CPO) 2022-14 and Capital Project Ordinance Amendments (CPOA) 2022-37 and 2022-38 to appropriate the grant funds for three Airport projects.

CPOA 2022-38 will appropriate \$923,527.00 for the Terminal Renovations Phase II; CPOA 2022-37 will appropriate \$800,000.00 for the 8-unit T-Hangar project; and CPO 2022-14 will provide \$400,000.00 for the General Aviation Hangar project.

Ms. Bianca Shoneman, Cool Springs Executive Director, stated the City Council has authorized a three-year contract with Cool Spring Downtown District, Inc. (CSDD) on June 22, 2020, to provide enhanced services for an arts and entertainment focused downtown municipal service district. Council is asked to approve an amendment to that contract by adding trolley operations to the scope of services and outline the responsibilities of the City and CSDD.
