#### THE QUESTION:

This is a follow up item to move forward with recommendations from the City's comprehensive compensation and classification study, as reviewed at Council's March work session.

#### **RELATIONSHIP TO STRATEGIC PLAN:**

This study is a Priority Policy Agenda item in the City's FY12 Strategic Plan. The project also relates to Goal 3 - More Efficient City Government - Cost-Effective Service Delivery and supporting opportunities for recruiting and retaining a top quality workforce.

#### **BACKGROUND:**

Our consultants recently completed the market salary survey and reviewed results and recommendations with Council during the March work session. Recommendations and proposed actions to support fair and equitable pay structures will be implemented.

#### ISSUES:

The City desires to successfully attract, recruit, and retain talent for City employment across all Departments to provide efficient, high quality, customer-focussed services for all citizens. Ensuring we have competitive pay and benefits is a critical foundation for employee morale and productivity.

#### **BUDGET IMPACT:**

Funding for this study was approved by City Council as part of the FY12 Budget. Preliminary cost information was reviewed with Council at the March work session, and will be submitted as part of the City budget for FY13. We would do best to fund the implementation based on the fiscal constraints and overall goals of the City.

#### THE QUESTION:

Whether Council wants to award a contract to Highland Construction in the amount of \$557,026.36

#### **RELATIONSHIP TO STRATEGIC PLAN:**

Growing City, Livable Neighborhoods, A Great Place to Live

#### **BACKGROUND:**

The City plans to rehabilitate a section of Fort Bragg Road from Bragg Boulevard southward to Churchill Drive. The roadway will be milled from Bragg Boulevard to Churchill Drive but will only be resurfaced to Barrington Cross. The section from Barrington Cross to Churchill Drive will be resurfaced after a drainage project has been completed.

#### **ISSUES**:

- Fort Bragg Road was last resurfaced in 1984 and is a concrete road with an asphalt overlay.
- The road currently is rated very poorly with section that have failed and are buckling.
- The roadway will be milled and then the concrete will be repaired or replaced as needed.

#### **BUDGET IMPACT:**

The contract amount for the project is \$557,026.36 which is below the city engineers estimate.

#### **OPTIONS**:

Award the Contract to the low bidder

Do not award the contract to the low bidder and re-advertise.

#### **RECOMMENDED ACTION:**

Staff recommends that Council move to award the Contract to the low bidder, Highland Construction, in the amount of \$557,026.36.

## **Background**




- The roadway hasn't been resurfaced since the early 80's.
- It is a 7" thick concrete road with 5 inches of asphalt over it.
- The concrete is causing the asphalt to buckle at joints and utility cut locations.






## **Contract Proposal**




- The project limit is from Bragg Boulevard southward to Churchill Drive for a distance of approximately 1.1 miles.
- The construction period is for 104 calendar days.
- The work involves milling the entire roadway to the concrete, repairing the concrete, adjusting utility boxes, resurfacing in 2-3 lifts and installing thermoplastic markings.
- The low bid from Highland Paving is \$ 557,026.36





The Public Works Commission of the City of Fayetteville requests Council approve bid recommendation for purchase of one (1) 230kV Circuit Breaker with optional Revenue Metering CT's for P.O.D. No. 1.

#### **RELATIONSHIP TO STRATEGIC PLAN:**

**Quality Utility Services** 

#### **BACKGROUND:**

The Public Works Commission, during their meeting of February 22, 2012 approved bid recommendation to award bid for purchase of one (1) 230kV Circuit Breaker with optional Revenue Metering CT's for P.O.D. No. 1 to Siemens Energy c/o National Transformer Sales, Raleigh, NC, lowest bidder in the total amount of \$91,100.00 and forward to City Council for approval. This is a budgeted item in the CIP Budget – EL45- FY2013 (budgeted amount of \$225,000). Delivery of the unit is 18 to 20 weeks after receipt of an order, therefore, it is anticipated that the unit will be received in FY 2013. Bids were received January 26, 2012 as follows:

NOTE: The low bid submitted by Alstom Grid, Inc. was found to be non-compliant with PWC specifications. The second low bidder, Pennsylvania Breaker, is relatively new to the circuit breaker market and has experienced notable problems with their first generation of breakers. Additionally, the purchase of this equipment is made up of (2) components: (1) the 230kV Circuit Breaker; and (2) Revenue Metering CT's. Progress Energy will be reimbursing PWC for the cost of the Revenue Metering CT's. Due to the cost breakdown of the bids, by awarding the bid to Siemens, PWC will actually be paying less for the circuit breaker, than if the bid was awarded to Pennsylvania Breaker.

RE: Community Street Banners for FTCC 50th Anniversary

#### THE QUESTION:

Whether or not to approve the special request for Community Street banners for FTCC.

#### **RELATIONSHIP TO STRATEGIC PLAN:**

Partnership of Citizens.

#### **BACKGROUND:**

The Code of Ordinances contains a provision, Section 30-5L10(c), allowing special permits for temporary community event banners. The Ordinance requires the banners be up for at least 90 days, but no more that 180 days and be 2 feet by 6 feet. The request is subject to the approval of City Council who may limit the number.

The banners depict the College's 50<sup>th</sup> Anniversary logo and are limited by Ordinance to 24 inches wide by 72 inches high. The original request was approved by City Council in September 2011, authorizing FTCC to attach a total of 36 banners to utility poles on the FTCC campus and the Botanical Gardens location on Eastern Blvd. The applicant has coordinated with PWC for approval to attach the banners to the utility poles.

#### ISSUES:

FTCC has requested a 90 day extension to the approval of 180 days expiring on March 12, 2012 so the banners can remain up during the spring graduation. The City Council has approved similar requests for similar events in the past.

#### **BUDGET IMPACT:**

No direct impact.

#### **OPTIONS:**

- 1. Grant the special request for up to 36 community street banners for the FTCC 50th anniversary from March 12, 2012 through June 12, 2012 (recommended).
- 2. Grant the special sign permit with a different limit on the number of banners and time frame.
- 3. Deny the special request.



#### THE QUESTION:

Does the City Council concur with NCDOT's request to enact municipal speed limit ordinances on NCDOT maintained streets?

#### **RELATIONSHIP TO STRATEGIC PLAN:**

Growing City, Livable Neighborhoods - A Great Place To Live

#### **BACKGROUND:**

A citizen's request was made to NCDOT to reduce the speed limit on SR 1111 (Braddy Rd), between SR 1108 (King Rd) and SR 1112 (Stoney Point Rd). NCDOT performed an investigation and found that development had increased to nearly 75 percent along this section of Braddy Rd. As a result NCDOT has recommended a speed reduction from 55 mph to 45 mph. Additionally, NCDOT will be replacing a vandalized curve warning sign in the southbound direction.

#### **ISSUES:**

If NCDOT and the City cannot agree on modifying the speed limit for a particular street the existing speed limit will remain in place.

#### **BUDGET IMPACT:**

The adoption of these ordinances will not have an impact on the budget. If approved, NCDOT will responsible for signing these changes.

This letter is in reference to a citizen's request made from Ms. Nellye Croft to reduce the speed limit on SR 1111 (Braddy Road), between SR 1108 (King Road) and SR 1112 (Stoney Point Road), in Cumberland County. Our staff has recently completed a traffic engineering investigation.

During this investigation, the existing conditions were reviewed along SR 1111 (Braddy Road). The roadway consisted of a two-lane, two-way pavement structure 0.95 mile in length. The pavement cross-section consisted of 21 feet with one horizontal curve. Grass shoulder widths varied from 6 to 12 feet. Painted pavement markings delineated the travel lanes. Residential development was nearing 75 percent. As a result of these conditions and prior studies performed on SR 1111 (Braddy Road), it was recommended to reduce the speed limit from 55 mph to 45 mph. In addition, it was recommended to replace a vandalized advance curve warning sign in the southbound direction.

Please present our recommendations to your City Council for their consideration and for the rescission and enactment of the appropriate ordinances. 

Review the Police Department accreditation process to identify training areas. Review audit findings and determine if the issues identified were also identified in the audit for corrective action. Review and analyze all data collected to determine if biased-based policing has occurred and if so, determine if it is a departmental problem or the result of individual officers. Immediately implement acceptable CALEA Accreditation training standards and identify specific and measurable goals to ensure the conduct of traffic stops (self-assessment and external assessment) meet the standards.

On January 24, 2012 NOBLE was contracted to perform the study.

Chief Jimmy Wilson, Lead Consultant with NOBLE will present those findings and recommendations.
