### **INVOCATION - PLEDGE OF ALLEGIANCE**

The invocation was offered by Gail D. McAfee, Chaplain NAACP, followed by the Pledge of Allegiance to the American Flag.

### **ANNOUNCEMENTS AND RECOGNITIONS**

Mayor Chavonne and Council Member Massey presented a proclamation to representatives from the E.E. Smith Marching Band and Roosevelt Pratt, Band Director, proclaiming October 22, 2007 to be E. E. Smith High School Marching Band Day.

Council Member Meredith announced the Bicycle Man is sponsoring a dinner sale on Saturday, October 27, 2007 at 2801 Rosehill Road from 11:00 a.m. to 5:00 p.m., and with proceeds going towards the purchase of a building for his ministry.

Mayor Chavonne announced beginning October 22, 2007, PWC water customers would be required to follow additional water restrictions as Fayetteville moved into Stage II of its water shortage ordinance. Mayor Chavonne outlined the additional restrictions.

Mayor Chavonne introduced a video shown during the North Carolina League of Municipalities Conference, Host City Event held at Pope Air Force Base on October 15, 2007. Following the video, Mayor Chavonne recognized B.E. Nichols, Fire/Emergency Management Chief, and George Breece, Host City Event Consultant, for their efforts towards a successful conference.

### 1. APPROVAL OF AGENDA

Council Member Williams added Item 7. "discussion to direct the City Manager to work out a proposal to repair the Rayconda Lake dam similar to a dam repaired in the Vanstory neighborhood" since it had been left off the agenda.

MOTION: Council Member Williams moved that Item 7. be moved to Item 5.A.

SECOND: Council Member Haire

Council Member Williams expressed concern that the citizens survey results would divide members of the Rayconda community and stated an affirmative vote on his motion would make the survey a mute point.

### **FRIENDLY AMENDMENT:**

Council Member Worthy proposed that Item 5. be discussed at Item 7.

Council Member Williams accepted the friendly amendment. Following discussion, Karen M. McDonald, City Attorney, clarified the motion before Council was whether to move Item 5. to Item 7.

VOTE: FAILED by a vote of 2 in favor (Council Members Williams and Worthy) to 7 in opposition.

At the request of Council, Dale E. Iman, City Manager, presented highlights of a boil water advisory issued for parts of Western Fayetteville by Aqua America, a private water system provider under the regulatory authority of the Department of Energy and Natural Resources and the North Carolina Utility Commission, and citizen concerns expressed to the city regarding the notification procedures for the advisory. Mr. Iman stated the city is specifically precluded from regulating private water companies and advised citizens with concerns about the notification system to contact the toll-free number for the North Carolina Utility Commission.

Annually, the City closes out several projects that have been completed in previous fiscal years and that are no longer active. The projects referenced above have been completed and the revenues and expenditures related to these projects have been audited. C. Special Revenue Project Ordinance 2008-7 (FY2008 Justice Assistance Grant Program)

A Justice Assistance Grant (JAG), totaling \$240,056 has been awarded to the Fayetteville Police Department and Cumberland County Sheriff's Office. This Special Revenue Project

Ordinance will appropriate the City's share, totaling \$146,620, for the JAG program. A local match is not required. The Police Department will use their portion of the grant for travel, training, and other departmental operating costs, as well as acquisition of special equipment such as a Digital Small Arms Trainer System, a Tetherless System for Glocks, and a Video Analysis System.

The Public Works Commission, during their regular meeting of October 10, 2007, adopted FY 2008 General Fund Budget Amendment #1. Adopt FY 2008 General Fund Budget Amendment #1. Adopt FY 2008 General Fund Budget Amendment #1 as recommended by PWC. The budget amendment increases the water and sanitary sewer transfer to the Annexation Fund by \$491,780 (total transfer of \$1,918,780). The additional transfer amount is based on an agreement with the City, after the original budget was approved, for the funding of

Mr. Teal reviewed the proposed amendment to the infill ordinance and stated the proposed changes would require the developer to hold a neighborhood meeting prior to the Planning Commission's public hearing and would exempt the infill public hearing where a project has been approved under conditional zoning. Mr. Teal stated the Infill Subcommittee and the Planning Commission reviewed the infill ordinance and felt these were the only changes needed.

This is the advertised public hearing set for this date and time. There being no one to speak, the public hearing opened and closed at 7:35 p.m.

# 4. CONSIDER AN AMENDMENT TO THE FAYETTEVILLE CODE OF ORDINANCES, SECTION 30-285.1 SCREENING FOR SALVAGE YARDS AND LOTS THAT STORE JUNK OR DAMAGED VEHICLES

Mr. Teal stated the ordinance amendment reflects discussion of City Council at their October 1, 2007 work session meeting and would require fencing and a vegetative buffer for property visible from a public right-of-way or abutting developed residentially zoned property. Mr. Teal stated property abutting vacant residentially zoned property would only be required to have a six-foot fence and there would be no buffer requirements for property abutting non-residentially zoned property. Mr. Teal stated fence material would include wood, brick, stone or chain link with slats. Mr. Teal responded to questions.

#### 5. REPORT ON RAYCONDA DAM

### A. Citizen Survey Results

Mrs. McDonald presented this item and stated based on a request received by the city for the establishment of three municipal service districts to pay for repairs to the Rayconda dam, and after determining it was legally permissible to create the municipal service districts for that purpose, letters were sent out to property owners. Mrs. McDonald stated the letters explained the proposal, to include the estimated tax rate, and asked property owners to respond regarding their interest in creating the municipal service districts. Mrs. McDonald reviewed the survey results by district and stated 65% of the property owners for the 257 parcels responded with 58% in favor, 40% opposed and 2% undecided.

Council Member Worthy asked whether property owners not in favor would be incorporated into the municipal service districts. Mrs. McDonald responded should Council approve the creation of municipal service districts, properties located within the districts could not be excluded. Additional questions followed.

### B. Consideration of Options for Addressing Needed Repairs to Dam

Mr. Iman stated options for addressing dam repairs in the community have varied considerably based on the specifics of each situation. Mr. Iman stated a comprehensive report is expected from the city's engineer on November 5, 2007.

Council Member Worthy asked that the report include information related to lakes on which dams were repaired using public funds and whether the lakes were then determined to be for public usage.

### 6. CONSIDERATION OF FUNDING COMMITMENTS FOR THE 2007 HOPE VI REVITALIZATION GRANT APPLICATION BEING SUBMITTED BY THE FAYETTEVILLE METROPOLITAN HOUSING AUTHORITY

Victor Sharpe, Community Development Director, presented this item and stated the Fayetteville Metropolitan Housing Authority was requesting commitments from the City of Fayetteville for the 2007 HOPE VI Revitalization Grant in the form of vacant land, construction of infrastructure, waiving of filing, permitting and connection fees, contribution of general funds and HOME and CDBG funds.

Mayor Chavonne introduced HOPE VI project team members Chuck Billand, The Communities Group; Dawn Driggers, Director of the Metropolitan Housing Authority; and Murray Duggins, United Realty.

At the request of Council, Mr. Billand provided information regarding the federal grant, leverage of funds and project schedule following submission of the application.

Council Member Williams spoke to attracting private investment dollars to the community.

MOTION: Council Member Evans moved to approve financial commitments for the 2007 HOPE VI Revitalization Grant contingent upon approval of a HOPE VI grant award.
