A. Announcements and Recognition

Council Member Bates presented a Proclamation to the Methodist University Women's Golf Team proclaiming Monday, June 11, 2007 as a Special Day of Recognition to acknowledge their outstanding accomplishments.

Council Member Worthy extended greetings to his granddaughter who was visiting from Charlotte, North Carolina.

Council Member Worthy recognized Steve Blanchard, PWC CEO/General Manager, and Wilson A. Lacy and Michael G. Lallier, PWC Commissioners, for receiving national recognition as a Diamond Level Reliable Public Power Provider. On behalf of PWC and the Commissioners, Mr. Lallier presented the RP3 plaque to the City of Fayetteville.

B. Resolution Amending the Stormwater Ordinance and Inter-local Agreement with Cumberland County

RESOLUTION OF THE FAYETEVILLE CITY COUNCIL AMENDING FAYETTEVILLE CITY CODE CHAPTER 23 IN ITS ENTIRETY INCLUDING REVISIONS WHICH AUTHORIZE THE CITY OF FAYETTEVILLE TO ADOPT AND LEVY THE BASE MONTHLY STORMWATER SERVICE FEE AND AN ADITIONAL STORMWATER FEE TO FUND STORMWATER DRAINAGE IMPROVEMENTS WITHIN THE CITY OF FAYETTEVILLE. R2007-031 Mr. Dale E. Iman, City Manager, stated the request is to increase the stormwater utility fees by \$2 per month per equivalent service unit, which will generate sufficient revenues to provide for approximately \$40 million in stormwater improvements over the next several years.

MOTION: Council Member Gonzalez moved to approve the resolution amending the Stormwater Ordinance and Interlocal Agreement with Cumberland County.

SECOND: Council Member Worthy

VOTE: PASSED by a vote of 8 in favor to 1 in opposition (Council Member Williams)

Council Member Haire asked how priorities would be set for stormwater improvements. Mr. Iman responded that identified projects are being reviewed and prioritized by the Engineering Department and Stormwater Advisory Board and will be brought to Council with recommendations for approval.

C. Adoption of the Fiscal Year 2007-2008 Budget Ordinance

The recommended Fiscal Year 2007-2008 budget was presented to City Council on May 7, 2007. Several work sessions and two public hearings have been conducted on the recommended budget and proposed fees for transit services, curbside recycling and storm water system projects. Adoption of the budget ordinance will establish the budget for fiscal year 2007-2008 as well as set the tax rate and approve the fee schedule.

Mr. Iman stated the budget ordinance incorporated revisions to the recommended budget consistent with City Council direction. Mr. Iman reviewed highlights of funding provisions and stated taxes would not be increased and a strong healthy fund balance would be maintained. Mr. Iman commended Council on the numerous hours they put into reviewing the budget.

Council Member Evans asked what action had been taken regarding improved city services. Mr. Iman stated issues brought forward during the June 7, 2007 public hearings were

being analyzed to determine what could be done within the fiscal resources available.

MOTION: Council Member Evans moved to increase the bus fee to \$1, eliminate transfer fees and keep senior and disabled fares at the current rate.

SECOND: Council Member Worthy

Council Member Haire asked if the \$82,300 reduction in the Cumberland Council Business Council funding could be earmarked for transit.

Council Member Williams spoke to priorities and legitimate government expenditures.

VOTE: PASSED by a vote of 8 in favor to 1 in opposition (Council Member

Williams)
