8.02 Presentation of the Recommended Fiscal Year 2014-2015 Budget and Setting of the Budget Public Hearing

Mr. Voorhees, City Manager, presented this item with the aid of a PowerPoint presentation and stated before recommending a tax increase, it is prudent to take a look at the history of Fayetteville's tax rates, the tax rates of our Cumberland County municipal governments, and the tax rates of our peer cities state-wide. As discussed at the Strategic Planning Retreat and Council orientation, Fayetteville has a relatively low tax base when compared to the ten largest cities in North Carolina and does not have the industrial property that these cities have. Average home values in Fayetteville are lower than our peer cities, though our commercial tax base makes up a similar proportion of total assessable property. This commercial property is not necessarily of high value, the net results in an unusually low property tax revenue stream per capita. Fayetteville generates \$288.24 per capita from property taxes, the lowest of the peer cities and falls outside of not just one, but two deviations below the mean of \$488.21. Any way you look at the data the property tax burden in Fayetteville on a per capita basis is dramatically lower than the other large cities in North Carolina. Therefore, the conclusion is that Fayetteville's unusually low tax burden per capita simply results in an underfunded municipal government and a City Council that is unable to direct resources to foster community change and meet community demands at the level desired. Mr. Voorhees gave an overview of what the recommended budget achieves and stated a recommended general tax rate of 49.8 cents, downtown Municipal Service District(MSD) tax rate of 10 cents, and Lake Valley Drive (LVD) (MSD) tax rate of 24.5 cents per \$100 value. It projects unassigned fund balance at 11%. It funds or advances Council's five strategic priorities. It funds the CIP/ITP. It transitions to a program budget with performance measures and continues to support best practice reviews of City support services. Mr. Voorhees provided a summary of the General Fund revenue and expenditure highlights. The presentation also covered the tax package, unassigned fund balance for general fund, CIP/ITP, Stormwater Utility fee, Environmental Services fund, transit fund, and the budget process.
