## 7.02 Adoption of Budget Ordinance Amendment 2024-2 to fund the upgrade of Long-Term Parking Lot Lighting and support Airport Marketing efforts

Council is asked to appropriate \$350,000.00 in additional funding to FY24 Airport Adopted Budget from Airport Reserve Fund. The Fayetteville Regional Airport has lost a bank of security lights that require immediate replacement due to age of lighting system and faulty underground infrastructure. The project will convert the current long-term parking lights to LED and enhance safety and security for passengers traveling in and out of the airport. Quote and ancillary costs return an estimate of \$150,000.00. On November 28, 2022, the Airport Director presented a new marketing initiative to City Council designed to promote ridership on signatory airlines currently serving Fayetteville Regional Airport. To better support that plan and other marketing initiatives, the airport would like to raise its current \$300,000.00 market budget to \$500,000.00 to better promote flying Fayetteville from our 11-county service area.

## 7.03 Adoption of Special Revenue Fund Project Ordinance 2024-8 to Appropriate Grant Award for Neville Street Drainage Improvements

The City has been awarded a North Carolina Hazard Mitigation Grant Program Grant for the Neville Street Drainage Improvement Project. The total amount of the grant is \$1,323,507.00. Staff is seeking authorization to accept the grant award and Council adoption of Special Revenue Fund Project Ordinance 2024-8 to appropriate the funding.

## 7.04 Adoption of Special Revenue Fund Project Ordinance 2024-9 to Appropriate Grant Award for Blounts Creek Stream Enhancement Conceptual Design

The City has been awarded a Golden LEAF grant for the conceptual design of the Blounts Creek Stream Enhancement portion of the Person and Russell Street Drainage Improvement Project. The total amount of the grant is \$200,000.00. Staff is seeking authorization to accept the grant award and Council adoption of Special Revenue Fund Project Ordinance 2024-9 to appropriate the funding.

9.03 Appointment Committee recommendation to remove a Parks and Recreation Advisory Board Member per Council Policy No. 110.1, Section II.A.3.a

Council Member Ingram stated the Appointment Committee met on August 22, 2023. The first item on the agenda was to discuss the removal of a Parks and Recreation Advisory Board member due to "deliberate or repeated discourteous treatment of the public or City employees". The Parks and Recreation Advisory Board is comprised of seven City Council appointed members, seven County Commission appointed members, and one School Board appointed member.

Council Member Ingram stated there have been numerous complaints, both verbal and written, regarding Mr. Darden Jenkins' deliberate and repeated discourteous treatment towards fellow Board Members and professional staff. In addition, there are two Cumberland County Commission appointed Parks and Recreation Advisory Board Members that have had the same complaints made against them. The City Council does not have the authority to remove County appointed Board Members.

Discussion ensued.

## 9.04 Adoption of Budget Ordinance Amendment 2024-1 (Carryover of Assigned Funds from Fiscal Year 2023)

Mr. Jeffrey Yates, Assistant City Manager, presented this item and stated routinely, the City may fund items in the current fiscal year, but for various reasons do not expend or encumber those funds during the fiscal year. For instance, a planned expenditure or project may be delayed. To address these circumstances and to ensure that funds are available to meet the Council's goals, the City assigns (designates) funds for specific purposes in the City's fund balance at the end of the fiscal year. When the Council approves the budget ordinance for the following fiscal year, it authorizes the City to re-appropriate funds assigned (designated) for a specific purpose, based upon the year-end financial statements.

As of June 30, 2023, there was \$46,500.00 of fund balance in the General Fund that was appropriated for travel and training for the Mayor, Council, City Clerk's Office, and City Manager's office; and \$3,478.00 for the Millennial Commission for future-specific purposes in the financial statements.

Budget Ordinance Amendment (BOA) 2024-1 will appropriate \$49,978.00 from the general fund for outstanding financial obligations at the close of the fiscal year 2022-2023 (FY23). These appropriations are to be funded through the general fund fund balance, since these funds were not expensed in the 2022-2023 budget year and will revert back to the available fund balance until appropriated again.
