CALL TO ORDER

Mayor Colvin called the meeting to order.

The invocation was offered by Council Member McNair.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance to the American Flag was led by Mayor and City Council.

MOTION: Council Member Haire moved to approve the agenda.

5.0 ITEMS OF BUSINESS

Youth Protection Ordinance

Mayor Colvin thanked the public for attending and explained the meeting is to work through the details of the ordinance. A public hearing will be called once or if the final version is prepared.

Mr. Kemberle Braden, Police Chief, presented this item with the assistance of a PowerPoint presentation and provided an overview of the proposed Youth Protection Ordinance. Chief Braden stated the ordinance was created to help address juvenile crime and safety and parental responsibility and would apply to individuals under the age of 18. The ordinance would be enforced within the incorporated city limits and include any associated penalties.

For juveniles between the ages of 16 and 17, the ordinance would be in effect Monday through Friday from 12:00 a.m. to 5:00 a.m., Saturday through Sunday from 1:00 a.m. to 5:00 a.m. and during truancy hours of 7:30 a.m. to 4:30 p.m. For juveniles under the age of 16, the ordinance would be in effect Monday through Sunday from 11:00 p.m. to 6:00 a.m. and during truancy hours. Businesses could be held

accountable if they allow minors to enter or remain on the property during curfew hours.

Mayor Colvin asked if the Police Department has connected with other partnering agencies such as Department of Social Services to aid in assisting families. Chief Braden stated a youth crime summit was recently held that included individuals from Cumberland County Schools, Department of Social Services, Department of Corrections, and others to discuss different opportunities. There is a 60-day return meeting to finalize actionable items.

Discussion ensued regarding concerns and recommended changes to the proposed youth protection ordinance.

Mayor Colvin summarized the concerns for review are truancy hours and enforceability; age limit; work with Community partners such as Cumberland County Elected Officials, Department of Social Services, Cumberland County Schools, Cumberland County Sheriff's Office, District Attorney, Non-governmental partners, and Judges; fine implementation versus providing life skills classes parents and mentorship for the minor; and inclusion of data on murder and assault charges for the whole year.

MOTION: Council Member Banks-McLaughlin moved to reject the ordinance as presented, amend it as City Council discussed, and bring together Cumberland County, Cumberland County Schools, Cumberland County Sheriff, Judges, and non-profit organizations to create a Memorandum of Understanding

stating the responsibilities of each partner.

SECOND: Council Member Ingram

VOTE: PASSED by a vote of 7 in favor to 3 in opposition (Council

Members Benavente, Dawkins, and Hondros)

MOTION: Council Member Benavente moved to direct staff to request

the ACLU provide a presentation on the ACLU Letter sent to

the City Council.

SECOND: Council Member Hondros

VOTE: PASSED by a vote of 8 in favor to 2 in opposition (Council

Members Haire and Dawkins)
