7.01 Watershed Master Plan Solutions for Blounts Creek

Approval of the 100 proposed solutions from the Blounts Watershed Study to enable staff to program them into the annual CIP prioritization process and pursue grants as applicable.

7.02 Watershed Master Plan Overview and Final Deliverables

The acceptance of the final deliverables for the following watershed studies: Little Cross Creek, Little Cross Creek Pilot, Beaver Creek 3, Cape Fear 2, and Rockfish Creek.

7.03 Cross Creek Watershed Study Downtown Area Update

Approve staff to pursue funding sources to further develop advanced conceptual design for the Channel Improvement Option, and approve staff to pursue funding sources to continue to evaluate Roses Lake as a dry detention option for potential flooding mitigation.

7.04 Fayetteville Forward Infrastructure Bonds - Proposed Sidewalk Project Locations

Council consensus on Sidewalk Option 1; to proceed with the projects identified from 2018 Pedestrian Plan and CIP as well as provide consensus on the Reallocation for Grant Matches Option 1; to reallocate \$500,000.00 of the proposed \$15 million Resurfacing GO Bond funds to use as grant matches to leverage additional funding to support eligible public infrastructure projects.

7.05 Adoption of Capital Project Ordinance Amendment 2024-3 and Special Revenue Fund Project Ordinance 2024-5 to Appropriate the Safe Streets for All Grant

Adopt the Special Revenue Ordinance 2024-5 to appropriate \$506,083.00 to develop a Roadway Safety Action Plan. The funding source for this appropriation will come from a Federal Grant from the U.S. Department of Transportation and the Federal Administration in the amount of \$404,867.00 with a local match being

transferred from the Capital Project Ordinance Amendment 2024-3 for the GO bonds public infrastructure projects in the amount of \$101,216.00.

7.06 Adoption of Capital Project Ordinance 2024-4 to Appropriate Federal Transit Administration (FTA) Grant NC-2023-063-00 and Local Funding for the Purchase of Replacement Scheduling Software for Paratransit

Adopt Capital Project Ordinance 2024-4 to appropriate \$251,869.00 for the purchase of replacement scheduling software for the Paratransit (FAST*Trac!*) service. The funding sources for this appropriation are \$181,869.00 of federal grant funding and \$70,000.00 of local funding provided by the Transit Operating Fund.

7.07 Adoption of Capital Project Ordinance 2024-5 to Appropriate Federal Transit Administration (FTA) Grant NC-2023-051-00 and Local Funding for the Purchase of a Replacement Diesel Bus

Adopt Capital Project Ordinance 2024-5 to appropriate \$315,000.00 for the purchase of one diesel replacement bus. The funding sources for this appropriation include \$100,215.00 of federal grant funding and \$214,785.00 of local funding provided by the Transit Operating Fund.

7.08 Accept Federal Aviation Administration (FAA) Grant (Airport Improvement Program 55), Authorize the City Manager to Execute the Agreement with the FAA, and Adopt Capital Project Ordinance 2024-3 and Budget Ordinance Amendment 2024-3 to Appropriate Grant and Local Match Funds for Passenger Boarding Bridge Replacement

Accept the Federal Aviation Administration (FAA) Grant 3-37-0021-055-2023 (Airport Improvement Plan 55) for the replacement of the Gate 4 Passenger Boarding Bridge, and to authorize the City Manager to execute the Agreement.

Adopt Budget Ordinance Amendment (BOA) 2024-3 and Capital Project Ordinance (CPO) 2024-3 to provide the budget for this project. The CPO will appropriate \$1,650,000.00 for the replacement of the Gate 4 passenger boarding bridge. The funding sources for this project are federal grant funds from the FAA (\$1,500,000.00), and a required local match from Airport Operating Fund net assets (\$150,000.00), which will be provided by the BOA appropriation.

7.09 Removal of Inadvertent Inclusion of the Prohibited Sign Removal from Right of Way Fee in the Fiscal Year 2023-2024 Fee Schedule

On June 21, 2023, Council adopted the Fiscal Year 2023-2024 Fee Schedule. The description of the Prohibited Sign Removal from the Right-of-Way fee was inadvertently included in the schedule. Council's approval of the removal of this fee is requested.

There is no impact to the General Fund.

Council accepts the administrative correction of the Fiscal Year 2023-2024 Fee Schedule previously adopted on June 21, 2023.
