1.A. AUDIT OF THE FINANCE DEPARTMENT TO DETERMINE IF CITY OF FAYETTEVILLE MONEY IS GOING TO THE WOMAN'S CLUB

Mr. Dale E. Iman, City Manager, reported the City of Fayetteville provided the Woman's Club with \$5,000.00 in FY 1997-1998 and \$3,750.00 in FY 1998-1999 for a total of \$8,750.00. Mr. Iman stated no further funds were provided by the City of Fayetteville to the Woman's Club after FY 1998-1999. Mr. Iman further stated the Arts Council reported in their thirty years of record keeping, they have not provided any funds to the Woman's Club through their grant programs. Mr. Iman explained the Arts Council transfers monies only through grants and not by direct payment.

Council Member Worthy asked how citizens could be assured that taxpayer dollars are not being redirected to the Woman's Club by organizations receiving funds from the city. Mr. Iman responded annual audits of organizations would reflect how the funds are handled. Council

Member Worthy asked for a report at the next meeting on whether PWC provides funds to the Woman's Club.

Council Member Evans recommended that Council Members determine which nonprofit organizations receive funding from the city. Council Member Williams concurred.

B. Comment Period

Mayor Chavonne opened the public comment period.

Mr. Paul Lawing, 708 Marketview Court, Fayetteville, NC, stated the Triangle Friendlies' soccer tournaments have been held in Fayetteville for the past seven years and have had a positive economic impact on the community. Mr. Lawing expressed concern that Fayetteville has done nothing to promote the tournaments even though the Triangle Friendlies have advertised the Fayetteville tournaments in the catalogs and publications of one of the largest soccer retailers in the world.

Ms. Jackie Washington, 341 West Summerchase Drive, Fayetteville, NC, expressed concern regarding water problems under her house in Fairfield Farms. Ms. Washington asked for help and stated she is unable to get any answers as to why there is water accumulation under her house.

Ms. Jean Hutchinson, 320 West Summerchase Drive, Fayetteville, NC, expressed concern regarding the structural longevity of her home, yard drainage problems and mold contamination related to water accumulation in the crawl space of her home in Fairfield Farms. Ms. Hutchinson stated twelve inspections have been performed on her house and each time she has been told everything was acceptable. Ms. Hutchinson asked that building codes and ordinances be better enforced.

Mr. Mark Ledger, 430 Lionshead Road, Fayetteville, NC, expressed concern about an individual approaching a vehicle at an ATM. Mr. Ledger asked that the Fayetteville Police Department be more aggressive with the enforcement of panhandling ordinances.

Mr. Amir Eronomy Muhammed, 2700 Murchison Road, Fayetteville, NC, complimented Council on their interactions with citizens during the recent referendum. Mr. Muhammed stated more North Carolina-based companies need to secure contracts with Ft. Bragg. Mr. Muhammed also stated Fayetteville needs to follow the example of Raleigh, North Carolina and hire a consultant group to find out what can be done to better satisfy citizens and advance construction progress. Mayor Chavonne asked staff for input regarding the drainage issues on Summerchase Drive. Mr. Iman stated a review by the State Board of Inspections revealed the inspections performed met the state codes. Mr. Iman further stated a review of the records revealed the situation is likely a civil matter between the homeowner and the contractor. Mr. Frank Simpson, Inspections Director, stated the homeowner filed a complaint with the Licensing Board against the contractor and the board chose not to take action against the contractor. Mr. Simpson stated a complaint was also filed against the Inspections Department and the report indicated no action needed to be taken against the inspector. Mayor Chavonne requested that Mr. Iman bring a comprehensive report of findings and recommendations back to Council. Mayor Pro Tem Massey asked that staff include recommendations for homeowners who have already purchased homes in the area.

At the request of Council Member Haire, Mr. Jerry Dietzen, Solid Waste Manager, provided a presentation regarding recommended revisions to the Solid Waste ordinance. Mr. Dietzen stated residents would continue to have free pickup of debris up to 20 cubic yards. Mr. Iman stated the ordinance is structured as such because it is difficult to differentiate between homeowner-generated and contractor-generated debris. Mr. Iman further stated the ordinance requires that all contractor-generated debris and waste be removed by the contractor.

VOTE: PASSED by a vote of 9 in favor to 1 in opposition (Council Member Evans)
4. PUBLIC HEARINGS:

A. Consider approval of an infill project located at 315 Tokay Drive containing five single-family housing units on 1.12 acres.

Mr. Jimmy Teal, Planning Director, presented this item and reviewed the percent of median requirements that initiated the public hearing before the Planning Commission on December 5, 2006. Mr. Teal stated the Planning Commission recommended approval of the infill project and a resident from the neighborhood appealed the decision of the Planning Commission thereby requiring a public hearing before the City Council. Mr. Teal stated the applicant's original development plan contained six townhouses; however, the applicant revised the development plan to five single-family houses after the appeal was submitted. Mr. Teal stated options before Council are to approve five single-family units, amend the recommendation to allow four units or deny which would permit the development of three units.

This is the advertised public hearing set for this date and time. The public hearing opened at 8:22 p.m.

Mr. Vernon M. Tigner, 3402 Marita Drive, Fayetteville, NC, appeared in opposition and stated the area is pretty well saturated with apartments and he did not see the need for any more. There was no one further to speak and the public hearing closed at 8:24 p.m.

Council Member Evans posed further questions to Mr. Tigner about traffic and crime in the area. At the request of Council Member Kirby, Mr. Teal reviewed infill ordinance requirements pertinent to the development plan.

5. Report on Biennial Citizen Satisfaction Survey

Mr. Doug Hewett, Management Services Director, introduced Mr. Tollie Mitchell of Insight Research who provided a review of the survey process and results. Council Member Kirby asked how the survey results were applied. Mr. Hewett stated the Senior Management Team hopes to incorporate appropriate actionable items into their work plans and Council can consider incorporating survey results into their Strategic Planning.
