Introduction of Fire Department Assistant Chiefs Benjamin Major and Christina Morey

B.E. (Benny)Nichols, Fire/Emergency Management Chief, introduced new Fire Department Assistant Chiefs Christina Morey and Benjamin Major. Chief Nichols noted both Assistant Chief Morey and Assistant Chief Major were entering their twenty-fourth year of service with the Fire Department.

Chief Nichols relayed events surrounding his acquisition of the badge of former Fayetteville Fire Department Chief, James Dobbin McNeill. 3. PUBLIC HEARINGS:

A. Approve the rezoning from R6 residential district to C1 commercial district or to a more restrictive zoning classification for property located west of Strickland Bridge Road and south of Graham Road. Containing 2.00 acres more or less and being the property of Rodger and Letha Pierce. Case Number P07-70F.

Mr. Garner showed a vicinity map and gave an overview of the current land use, current zoning, surrounding land use and zoning, and 2010 Land Use Plan. Mr. Garner stated the applicant wishes to redevelop a former mobile home site to a commercial use and although the 2010 Land Use Plan map for the site suggests medium density residential uses, there are commercial and institutional uses in the area. Mr. Garner stated the Zoning Commission concurred with the applicant's request and recommend approval of the rezoning request.

This is the advertised public hearing set for this date and time. The public hearing opened at 7:20 p.m.

Jerry Flood, 1133 Chestwood Drive, Fayetteville, NC appeared in favor and stated the property would be used for a professional office complex.

Joe Weston, 6516 Lagoon Drive, Fayetteville, NC appeared in favor and expressed the need for office space for 125 employees.

Jean Weston, 6516 Lagoon Drive, Fayetteville, NC appeared in favor and stated the request is for office space on one side and an after school program on the other side.

Deloris Leflore, 2111 Coinjock Circle, Fayetteville, NC appeared in opposition and expressed concern about further commercial development and traffic overflow.

Willie Jene Freeman, 2109 Coinjock Circle, Fayetteville, NC appeared in opposition and expressed concern for traffic problems.

At the request of Council Member Haire, Mr. Garner explained the differences between C1, P2 and P4 zoning. Mr. Garner stated under P2 and P4, offices would be a permitted use and an after school program would not be a permitted use but could be allowed with a Special Use Permit.

Council Member Crisp asked whether there were plans for a traffic density study on Stickland Bridge Road, what safeguards existed to prevent another trailer park from locating on the property and whether a site plan would show what is to be constructed on the property. Mr. Garner stated he was not aware of a traffic study, a request for an overlay district would have to come before Council for another mobile home park to locate on the property and P4 zoning would require a site plan.

There was no one further to speak and the public hearing closed at 7:26 p.m.

MOTION: Council Member Haire moved to rezone the property to P4.

Motion died due to lack of a second.

MOTION: Council Member Meredith moved to deny the rezoning request.

SECOND: Council Member Evans

Council Member Bates asked if a Special Use Permit would be required for an after school program under the current R6 zoning. Mr. Garner responded in the affirmative but stated office use would not be allowed under R6.

VOTE: PASSED by a vote of 8 in favor to 2 in opposition (Council Members Massey and Haire)

B. Consider an application by John Gillis for a Special Use Permit for a skilled nursing and rehabilitation center in an R5A residential district for vacant property located at the intersection of Old Bunce Road and Seventy-First School Road. Containing 18.5 acres more or less and being the property of Gillis Properties. Case Number P07-72F Mr. Garner showed a vicinity map and gave an overview of the current land use, current zoning, surrounding land use and zoning, and 2010 Land Use Plan. Mr. Garner stated the applicant wishes to locate a skilled nursing and rehabilitation center at this location. Mr. Garner further stated this use is allowed on R5A residentially zoned property with approval by City Council of a Special Use Permit. Mr. Garner stated the Zoning Commission recommends approval of the nursing and rehabilitation center with conditions.

Council Member Bates asked about the required improvements for access to the facility from Seventy-First School Road following which Mr. Garner provided a review of the site plan and proposed turn lanes into the site.

This is the advertised public hearing set for this date and time. The public hearing opened at 7:40 p.m.

Neil Yarborough, Attorney for Autumn Corporation, 115 E. Russell Street, Fayetteville, NC appeared in favor, provided an overview of the Autumn Corporation and Cape Fear Valley Health System joint venture project and stated the facility would address critical hospital stepdown needs in the community.

Doug Suddreth, Vice President for Autumn Corporation, PO Box 1579, Morganton, NC, appeared in favor and provided an overview of the proposed facility to include capacity and design characteristics.

Don Curry, 3344 Hillsborough Street, Suite 250, Raleigh, NC appeared in favor and reviewed exhibits portraying the civil aspects of the project, specific site issues and coordination efforts with NCDOT and city staff.

Neil Yarborough, Attorney for Autumn Corporation, 115 E. Russell Street, Fayetteville, NC appeared in favor and asked Council to follow planning staff recommendations.

Nathaniel Patillo, Remington Homeowners Association, 6572 Foxberry Road, Fayetteville, NC appeared in opposition, expressed concern for traffic on Seventy-First School Road, kids walking to school without sidewalks and requested that the exit be located on Old Bunce Road.

Neil Yarborough, Attorney for Autumn Corporation, 115 E. Russell Street, Fayetteville, NC appeared in rebuttal and stated the property as currently zoned has the potential to generate 1,800 cars per day whereas the proposed facility will generated 320 cars per day and ameliorate potential traffic problems to Seventy-First School Road.

Nathaniel Patillo, Remington Homeowners Association, 6572 Foxberry Road, Fayetteville, NC appeared in rebuttal and reiterated his concerns regarding traffic on Seventy-First School Road and the safety of children who walk along the roadway to school.

There was no one further to speak and the public hearing closed at 8:05 p.m.

A brief discussion ensued regarding required locations for sidewalks under the preliminary site plan and possible construction of multifamily units under the current zoning.

MOTION: Council Member Meredith moved to approve the Special Use Permit for a skilled nursing and rehabilitation facility with the conditions as outlined and add conditions which would speak to the enhancement to Seventy-First School Road for traffic.

SECOND: Council Member Evans

Council Member Haire asked whether in lieu of sidewalk construction funds could be used to supplement construction of sidewalks on Seventy-First School Road. Mayor Chavonne stated consideration could be given once a specific site plan is submitted.

Mr. Teal clarified sidewalks would be required when remaining property abutting Bunce Road and Seventy-First School Road is developed.

VOTE: PASSED by a vote of 8 in favor to 2 in opposition (Council Members Applewhite and Haire)

C. Consider extending the corporate limits of the City of Fayetteville for a petition-initiated contiguous annexation by North Ramsey Partners, LLC. (Located on western side of Ramsey Street between Fairfield Farms subdivision and South River Electric Coop)

Jimmy Teal, Planning Director, presented this item and stated the annexation petition is submitted in order to receive PWC water and sewer service as outlined in City Council Policy# 150.2. Mr. Teal stated the recommendation is to annex the property effective December 17, 2007.

This is the advertised public hearing set for this date and time. There being no one in favor or in opposition, the public hearing opened and closed at 8:17 p.m.

AN ORDINANCE TO EXTEND THE CORPORATE LIMITS OF THE CITY OF FAYETTEVILLE, NORTH CAROLINA. ANNEXATION ORDINANCE NO. 2007-12-503

MOTION: Council Member Bates moved to adopt the annexation ordinance with an effective date of December 17, 2007.

SECOND: Council Member Mohn

VOTE: UNANIMOUS (10-0)

D. Consider a waiver to construct asphalt curbing rather than concrete curbing for the remaining unpaved streets in the James Creek and Scotts Mill subdivisions.

Mr. Teal stated Greg Floyd has constructed approximately 85% of the subdivision using asphalt curbing and wishes to complete the remaining 15% with asphalt curbing. Mr. Teal stated the county approved Mr. Floyd's plans in September 2005 allowing him to construct the subdivision with asphalt curbing through September 29, 2007. Mr. Teal further stated that beginning September 30, 2007, the two-year period expired and the required city standard is concrete curbing. Mr. Teal stated the Planning Commission recommends approval of the waiver. This is the advertised public hearing set for this date and time. There being no one in favor or in

E. Consider a request for payment in lieu of sidewalk construction on River Road as requested by John Koenig.

Mr. Teal stated the subdivision ordinance and city council policy provides an opportunity for an individual to request payment in lieu of constructing the required sidewalk. Mr. Teal further stated Mr. Koenig's required sidewalk length abutting River Road is 930 feet and at \$33 per linear foot, provides a payment of \$30,690. Mr. Teal stated the Planning Commission recommends approval of the payment in lieu of request.

Council Member Crisp inquired about the existence of sidewalks along River Road. Mr. Teal responded there currently are no sidewalks on River Road.

This is the advertised public hearing set for this date and time. The public hearing opened at 8:23 p.m.

John Koenig, 1713 Wilmington Highway, Fayetteville, NC appeared in favor and stated there will be over ten miles of sidewalks within the development and there will be additional sidewalks and walking trails in the conservation district along the river.

No one appeared in opposition and the public hearing closed at 8:25 p.m.

MOTION: Council Member Bates moved to deny the request for payment in lieu of sidewalk construction.

The motion died due to lack of a second.

MOTION: Council Member Massey moved to approve the request for payment in lieu of sidewalk construction.

SECOND: Council Member Meredith

Council Member Bates stated sidewalks should be constructed along River Road because of future development along the river.

VOTE: PASSED by a vote of 6 in favor to 4 in opposition (Council Members Chavonne, Evans, Haire and Bates)

F. Consider an amendment to the Fayetteville Code of Ordinances, Sections 30-107, 30-117 and 30-125, Zoning, to institute a separation of 500 feet from daycares, schools and places of worship from bars and adult entertainment establishments.

Mr. Teal stated City Council earlier this year requested a separation of daycares from bars. Mr. Teal stated the Planning Commission developed an ordinance separating daycares, schools and places of worship from bars and adult entertainment establishments with a 500-foot separation requirement. Mr. Teal further stated existing establishments within 500 feet would remain as legal non-conforming uses. Mr. Teal stated the Planning Commission recommends approval of the amendment.

In response to a question posed by Council Member Haire, Mr. Teal stated if a bar closed and did not reopen within one year and a daycare was located next to it, the bar could not reopen at that location and would be a legal nonconforming use under the proposed amendment.

Council Member Massey asked about the separation distance under state regulations. Mr. Teal responded the state requires 50 feet separation between bars and schools or daycares.

This is the advertised public hearing set for this date and time. The public hearing opened at 8:30 p.m.

No one appeared in favor.

Benjamin Washington, 612 Rowan Street, Fayetteville, NC appeared in opposition and expressed concern about his ability to resell his business and gain financially should it become a nonconforming use on the 366th day.

There was no one further to speak and the public hearing closed at 8:33 p.m.

Mrs. Karen M. McDonald, City Attorney, and Mr. Teal responded to questions and provided clarification on the proposed ordinance amendment.

G. Consider an amendment to the Fayetteville Code of Ordinances, Section 30-541, Planning Commission Membership, to add two alternates to the Planning Commission membership roster.

Mr. Teal stated the Planning Commission is requesting two alternate members to their roster so they will have a full complement of members whenever a regular member is absent from a meeting. Mr. Teal explained this would coincide with the membership roster for the Zoning Commission. Mr. Teal stated the Planning Commission recommends approval of the amendment.

This is the advertised public hearing set for this date and time. There being no one in favor or in opposition, the public hearing opened and closed at 8:40 p.m.

4. A REPORT ON PROPOSED CHANGES TO THE RECREATION AND OPEN SPACE REQUIREMENT AS REQUESTED BY CITY COUNCIL

Mr. Teal presented this item and stated the City Council, at the August 6, 2007 work session, requested staff to look at increasing the amount of open space required and the method used for payment in lieu of providing open space. Mr. Teal explained the proposal includes increasing the required open space from 500 square feet to 800 square feet per residential unit, calculating payment in lieu of open space on post-development land value rather than predevelopment land value and requiring city council approval for payment in lieu of open space for developments with greater than five units.

MOTION: Council Member Meredith moved to have staff bring the proposed changes to the earliest available work session for more detailed discussion.

SECOND: Council Member Bates

VOTE: UNANIMOUS (10-0)

REPORT ON DAM REPAIRS

Dale E. Iman, City Manager, reviewed the categories of private lakes and dams in Fayetteville and reviewed a proposed policy that outlined the city's participation in maintenance, repair and upgrades for each category. Mr. Iman stated the policy is meant to be sustainable, ongoing and affordable for the city and provide benefits and viable options for affected property owners of private dams. Mr. Iman defined affected property owners, with reference to the policy, as those individuals or other legal entities that own real property within the boundaries of the Municipal Service District (MSD) and are thereby subject to the special tax provisions of the MSD.

Mr. Iman summarized benefits to owners of private dams supporting city streets as contained in the proposed policy.

MOTION: Council Member Meredith moved to adopt the amendment to City Council Policy 125.1.

SECOND: Council Member Massey

Council Member Mohn asked whether there were state or federal funds available for properties within the national wetlands inventory. Mr. Iman stated there are no funds available at this time because the Department of Environment and Natural Resources (DENR) regulate

wetlands in North Carolina.

Council Member Bates asked how the affected property owners would be determined. Mr. Iman responded residents in the neighborhood would structure the boundaries for the creation of the MDS and determine who the affected property owners would be.

Council Member Massey asked whether stormwater funds could be utilized for dam repairs. Mr. Iman responded the \$43 million in stormwater projects identified when the stormwater fee structure was calculated did not include repairs to any dam structures within the city.

Council Member Crisp asked whether a minimum of 51% of the affected property owners in the Rayconda dam area would have to petition the City Council for the creation of a MSD. Mr. Iman responded in the affirmative and stated a public hearing would have to be held in accordance with state statute.

A brief discussion ensued about implementation of the policy relative to past dam repairs. Mr. Iman stated past dams still in need of repairs could apply for funds in accordance with the proposed policy.

VOTE: UNANIMOUS (10-0)
