

He reported further, that the extension granted would expire on August 31, 1963.

Planning Director Rumbough gave a report on the parking lot proposed for the old Central School site and presented several plans for the Council's study. Following some discussion, Councilman Holt moved for approval of the parking lot plan recommended by the Planning Director and for letting of the contract for construction. Motion was seconded by Councilman Packer and approved unanimously.

Upon motion by Councilman Plummer, seconded by Councilman Rhodes, Council voted unanimously to follow recommendation of the Civil Service Commission, the City Manager, and the Chief of Police and appointed HERMAN BROADUS HUBBARD to fill a vacancy in the Police Department.

Upon motion by Councilman Rhodes, seconded by Councilman Plummer, Council voted unanimously to follow recommendation of the Civil Service Commission, the City Manager and the Fire Chief and appointed the following as Company Officers in the Fire Department:

Councilman Plummer moved that the North Carolina State Highway Commission be requested to make a survey regarding the installation of a traffic signal at the intersection of Country Club Drive (N. C. Highway 59) and Ramsey Street (U. S. Highway 401 North). Motion was seconded by Councilman Packer and carried unanimously.

Upon motion by Councilman Plummer, seconded by Councilman Rhodes, Council voted unanimously to accept Hobson Street (between Fort Bragg Road and Bragg Boulevard, 3000 block) dedicated in 1942 by Miss Florence Rogers as recorded in Plat Book 10, page 42, as a 30-foot wide street and to advertise a public hearing for August 26, 1963 for the paving of Hobson Street, without petition, by adoption of the following resolution:

PRELIMINARY RESOLUTION  
REQUIRING THE PAVING,  
WITHOUT A PETITION,  
OF  
HOBSON STREET

After careful study and consideration of the matter and of all pertinent facts and circumstances, including engineering and planning studies and advice, and in the exercise of its best legislative judgment, the City Council of Fayetteville, North Carolina, finds as fact that:

1) The paving of Hobson Street is necessary in order to connect streets already paved, to wit, Bragg Boulevard and Fort Bragg Road;

and

2) The public interest, safety, convenience and general welfare requires the paving and other below described improvement of Hobson Street;

and

3) The property abutting on said street to be so paved and improved will be benefited by such pavement and improvement to the extent of the part of the cost thereof to be assessed, as stated below, against such abutting property;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF FAYETTEVILLE, NORTH CAROLINA, DOES ORDER THAT:

1) All of that portion of HOBSON STREET which lies between FORT BRAGG ROAD AND BRAGG BOULEVARD, shall be paved and curbs and gutters laid thereon, the cost of such improvements (exclusive of so much of said cost as is incurred at street intersections) to be specially assessed in the amount of two-thirds thereof upon the lots and parcels of land abutting upon said improved street portions according to the extent of the respective frontage thereon by an equal rate per foot of such frontage, to be paid after completion of such work and within thirty (30) days after notice of the assessment, in cash with no interest, or in five equal annual installments, bearing annual interest at six (6%) percent, payable annually.

2) A meeting of the City Council of Fayetteville will be held at the City Hall of Fayetteville at 8:00 P. M. on the 26th day of August, 1963, on the proposed improvements when all objections to the legality of making said proposed improvements shall be made in writing, signed in person or by Attorney, and filed with the Clerk of the City of Fayetteville at or before such time, and any such objections not so made will be waived.

3) This resolution and order shall be published once in THE FAYETTEVILLE OBSERVER, a newspaper published in the City of Fayetteville, ten (10) days before the time fixed for said meeting.
