downtown area or City as a whole and shallnnot serve in any manner to advertise or promote an individual business, groups of businesses, or a product.

(5) Canopies erected under these provisions shall be maintained in a satisfactory manner including periodic painting and constant proper drainage.

(6) Alterations in the canopy, uniformity of color scheme, or otherwise shall be made only after approval in the same manner as original plans.

Set. 2. This ordinance Shall be in full force and effect from and after its adoption.

Councilman Rhodes then moved for approval of the Association's sidewalk canopy construction plans as submitted and for the limitation of the City's financial obligation in the construction of said canopies to \$3,592.00 for concrete slab, steel decking and anchorage of steel decking in the 100 block of Hay Street. Motion seconded by Councilman Holt and carried unanimously.

Mayor Clark read a letter of request from Carolina Telephone and Telegraph Company requesting renewal of their franchise with the City for the maintenance and operation of their telephone facilities in the City of a period of thirty (30) years.

Councilman Rhodes moved for renewal of Carolina Telephone and Telegraph Company's franchise for the thirty (30) year period as requested. Motion seconded by Councilman Plummer and carried unanimously for the first reading. Second reading of the franchise for final approval was set for the next regular meeting of the Council on Monday, September 9, 1963.

Continuing the discussion of the granting of a franchise for a community TV antenna; Council recognized Mr. Ritchie Smith, Attorney representing local TV dealers and repairmen, who requested that the matter not be discussed at this time since he had not received notice in sufficient time to prepare his argument against the granting of such a franchise.

Councilman Plummer moved to table the matter until the next regular meeting and that at that time it be placed first on the agenda. Following a brief duscussion, Councilman Plummer withdrew his motion and Council recognized Mr. Stacy Weaver, Attorney for the Fayetteville Cable Corporation, the firm seeking the franchise. Mr. Weaver presented the redrafted franchise and requested Council approval of same. There was some discussion of the redrafted franchise. It had been suggessted that the franchise state specifically that there be joint pole use agreement between Public Works Commission and the licensee before approval of the franchise.

Councilman Packer moved that it be specifically agreed that before the franchise shall be operative, a joint pole use agreement shall be entered into between Public Works Commission and Licensee and that the franchise contain this condition. Motion seconded by Councilman Holt and carried unanimously.

Council then heard arguments pro and con from Attorneys Weaver and Smith regarding the granting of the franchise with Attorney Smith presenting a petition signed by some 22 dealers in opposition to and requesting rejection of a franchise for a community TV antenna.

Councilman Rhodes then moved that a franchise for a community TV antenna be granted to Fayetteville Cable Corporation. Motion seconded by Councilman Holt and the vote was as follows: FOR THE MOTION: Councilmen Rhodes, Holt, and Packer. AGAINST THE MOTION: Councilman Plummer and Mayor Clark. The motion carried first reading. Second reading was set for the next regular meeting on September 9,1963.

Upon motion by Councilman Plummer, seconded by Councilman Packer, approval was given the developer of Greenbriar Hills to pave the streets in Breenbriar Hills Sub-division by private contract subject to the approval of Public Works Commission and the City Engineer.

Upon motion by Councilman Rhodes, seconded by Councilman Plummer, a public hearing was ordered by unanimous vote for September 23, 1963, ontthe rezoning of the Janie Vaughn property on Fort Bragg Road from R6 Residential District to Cl Local Business District.

Councilman Plummer moved that the Mayor and City Council of Fayetteville respectfully request the State Highway Commission add to their system of streets within the City Limits of Fayetteville; North Broad Street from Person Street to Grove Street and Grove Street from Eastern Boulevard (U.S. 301) to North Broad Street and

that the State Highway Commission pave these two short streets in accordance with the City's Master Thoroughfare Plan.

The purpose in requesting the Commission to take the foregoing action is to relieve the traffic congestion at Eastern Boulevard and Person Street by allowing the traffic to proceed along Grove Street and North Broad Street and eliminate turning movement of traffic traveling on N.C. 210 at Eastern Boulevard and Person Street as well as Eastern Boulevard and Grove Street.

Motion was seconded by Councilman Packer and the resolution was unanimously adopted.

Due to the lateness of the hour, Councilman Rhodes moved at 11:10 P.M. for adjournment of the meeting until 7:30 P.M., Tuesday, August 27, 1963, in the City Hall Court Room. Motion seconded by Councilman Plummer and carried unanimously.
