

Exchange the \$100,000 Fire Station Bond Anticipation Note dated December 19, 1963, maturing February 19, 1964, numbered 1, and bearing interest at the rate of 2.15% per annum, for the \$100,000 Fire Station Bond Anticipation Note dated August 19, 1963, maturing December 19, 1963, numbered 1, and bearing interest at the rate of 1.82% per annum.

Exchange the \$300,000 Street Improvement Bond Anticipation Notes dated December 19, 1963, maturing February 19, 1964, consisting of 3 notes of the denomination of \$100,000 each, numbered 1 to 3, inclusive, and bearing interest at the rate of 2.15% per annum, for the \$300,000 Street Improvement Bond Anticipation Notes, dated August 19, 1963, maturing December 19, 1963, consisting of 3 notes of the denomination of \$100,000 each, numbered 1 to 3, inclusive, and bearing interest at the rate of 1.82% per annum.
