1.0 CALL TO ORDER

Council Member Haire called the meeting to order at 10:40 a.m.

2.0 ITEMS OF BUSINESS

OFFICE OF COMMUNITY SAFETY

Mr. Jeffrey Yates, Assistant City Manager, provided an overview of this item and stated the Office of Community Safety Director would report directly to the City Manager. The Office of Community Safety (OCS) would be built out on the four pillars: Mental Health Response and Diversion, Violence Prevention and Interruption, Homeless Risk Reduction and Youth Opportunities. Mr. Yates provided a spreadsheet of the OCS budget.

Discussion ensued.

Council Member Benavente requested an additional \$1.5 million be added to the OCS budget.

PUBLIC SAFETY MARKET ADJUSTMENTS

Mr. Jeffrey Yates, Assistant City Manager, presented this item and stated the ad valorem tax rate increase of \$.05 is recommended to fund the Public Safety market and compression adjustments. allows the City to keep pace when competing for applicants.

Mayor Colvin stated he wanted to see a comparison of the pay ranges with our peer cities.

Council Member Hondros asked who approves pay raises and promotions in the Police Department. Mr. Douglas Hewett, City Manager, stated he has the final decision on pay increases and promotions.

STORMWATER ENTERPRISE FUND

Mr. Byron Reeves, Public Services Assistant Director, presented this item and provided an overview of the Stormwater Utility Fund and the Stormwater Capital Plan.

ENVIRONMENTAL SERVICES FUND

Mr. Jeffrey Yates, Assistant City Manager, provided an overview of this item, and stated the budget has a recommended \$10.00 per year fee increase. Discussion ensued pertaining to loose leaf and yard waste pick-up services.

TRANSIT ENTERPRISE FUND

Ms. Tyffany Neal, Transit Director, presented this item and stated the Transit Department has hired a consultant that is conducting an equity study to review rates and routes. Using general fund balance to maintain "inefficient" routes to study and revise, and continues funding for bus replacements.

PARKING LOT ITEMS

Mr. Jeffrey Yates, Assistant City Manager, went over the list of items: \$500,000.00 to maintain right-of-way maintenance and litter pick-up crews, \$50,000.00 additional funding for neighborhood signage, Police Department compression steps, Police Department peer city comparison for pay, additional funding for water and sewer at Johnson Street, subscriptions for loose leaf and yard waste pick-up, and an additional \$1.5 million for the Office of Community Safety.
