The projects were completed in a previous fiscal year, audited by the City's external auditors as a part of the annual audit process and are ready for closure. Each closeout provides a brief description of the project or grant, the year the project ordinance was adopted, and the final revenue and expenditure budgets and actuals that are being closed.

# 6.08 Ordinance Authorizing a Petty Cash Fund - NCGS 159-28(d)

Mr. Ted Voorhees, City Manager, asked Ms. Lisa Smith, Chief Financial Officer, to provide an overview of this item. Ms. Smith stated petty cash funds are maintained by various City departments to provide a convenient and economical method to make small purchases less than \$125.00. The funds are maintained at a specific monetary level and expenditures are reimbursed. The City currently has 11 petty cash funds in 8 departments (Parks, Legal, Fire, Police, Airport, Engineering & Infrastructure, Parks and Recreation, and Environmental Services) which total \$4,950.00. North Carolina General Statute 159-28(d) amended by House Bill 44 Third Edition adopted June 10, 2015, permits the use of petty cash funds provided the local government has adopted an ordinance authorizing the use. Petty Cash funds are to be used in order to promote efficiencies and are governed by internal Policy No. 306, Petty Cash Funds Operation/Monitoring.

# 8.01 Airport Terminal Design Team Presentation 100% Schematic Design

Mr. Brad Whited, Airport Director, stated in 2015, the FAA provided the Airport with a design grant to develop bid and specifications during the summer of 2016. The design team has worked with Airport Management, Terminal Stakeholders, the local FAA, the local TSA and PWC to develop the schematic plans prior to developing detailed plans and specifications for the project. Bidding is scheduled for late May or early June 2016. The Design Team includes an element to reach out to local contractors and DBE businesses to communicate opportunities for general contracting, sub-contracting and explanation of the NCDOT/DBE certification process and requirements. Our goal is to increase the opportunity and percentage of local and DBE participation. Airport Terminal Improvement Design is at the 100 percent of schematic plans. The next design element is to prepare specifications for bid.

Mr. Whited introduced Mr. Gordon Johnson, Project Architect, Talbert & Bright and Gordon Johnson Architecture. Mr. Johnson presented the Schematic Design for the reconstruction of the airport terminal building with the aid of a PowerPoint presentation. Construction is expected to begin in fall of this year and will have a 28- to 30-month construction period.

Discussion ensued pertaining to hiring Disadvantaged Business Enterprises (DBE) for sub-contract work on this project.
