# **Operation Ceasefire:**

This year, 47 probationers attended our call-ins. Forty-four of those who attended had case plans developed by our Resource Coordinator. 100% of the probationers who made a case plan were seeking employment. 6 were employed within the first two months following the call in. 40% of the probationers have enrolled in vocational skills training courses offered at Fayetteville Technical Community College. The grant pays for this training.

Operation Ceasefire conducted 9 movie nights this year. Approximately 1805 individuals attended these events. At each event, we partnered with Cumberland County law enforcement agencies, Partnership for Children and local volunteers to hand out gun locks, posters, flyers, crime prevention materials and items containing our message.

Operation Ceasefire partnered with the Fayetteville FireAntz Southern Professional Hockey League team to hold a public safety night in February 2009. Approximately 4,300 individuals attended the game that night. We handed out over 500 flyers, posters, PSN materials, gun locks and branded materials. We set up the movie screen at the box office area and showed game highlights and PSA's with our PSN message.

We also partnered with the Downtown Alliance to hose a movie night at Festival Park during the Glory Days celebration. Approximately 400 people attended this event.

In October, we partnered with the Fayetteville Swamp Dogs to host "Trunk or Treat". This was very successful and was attended by over 1000 people. We would like to make this an annual event.

### Violent Crimes Task Force:

The Violent Crimes Task Force submitted 43 cases to the United States Attorneys Office this year. They continued participate in the Operation Ceasefire, "Movie Nights" and provided statistical data for the various grants associated with the program.

This year has seen several changes in the personnel and operation of the task force. ATF Residence Agent in Charge Joe Lenczyk, accepted a position in Florida and his position has yet to be named. ATF Agent Jeff Key is currently the acting RAC and had directed the task force to become more involved in major cases as they are happening instead of waiting for report and arrest. He has also implemented a spreadsheet that will be used to better track the status of cases sent to the VCTF for review.

# Violent Fugitives Task Force:

The Violent Fugitives Task Force is responsible for the arrest of 461 people during 2009. In March, they implemented "Operation Falcon". This warrants special utilized resources for various federal, state and local law enforcement agencies and resulted in 350 warrants being served in one month.

The department continues to rely on the VFTF to obtain phone records and locate violent fugitives. The VFTF made 16 murder and 15 sex offender apprehensions in Fayetteville / Cumberland County this year.

# **Crack House Task Force**

For 2009, the Unit served, seized, or accumulated the following:

- 116 search warrants served
- 21 lbs. of marijuana
- 514 grams of cocaine
- 908 dosage units of prescription medication
- 827 dosage units of ecstacy
- .7 grams of heroin
- 439 felony arrests
- 140 misdemeanor arrests
- 52 weapons
- \$46,862 U.S. Currency seized
- Total Value of Narcotics Seized: \$154,094

The following search warrants / cases were considered to be the highlight of 2009:

- 2213 Cattail Circle
- 5331 Mesa Court
- 2104 Rosehill Road
- 3230 Rogers Drive
- Reversal of 400 grams of cocaine from Farrell Chatman which led to the seizure and case adoption of DEA. Below are combined estimates of drugs and assets seized as a result of those operations. It should be noted Suppression could not have been successful without assistance from ERT and Federal Authorities.
