ITEM 3: Introduce the Employee of the Quarter

Mr. Whited introduced Mr. Sammie Green. Mr. Green was hired about six months ago as our Equipment Operator I. Prior to that, he worked with us as a temporary custodian while working full time with Cumberland County Schools. We had an opening for Equipment Operator I and Mr. Green was hired. Mr. Whited wanted to note that Mr. Green was voted almost unanimously by his peers. Mr. Green has fit in well with the Airport family and he is a valuable asset to us and the City.

ITEM 4: Management Notes

Enplanements. Total enplanements for all carriers as of August 2016 were 19,252. This indicates a .5% decrease compared to August of last year and a 2.5% increase year to date.

USO visitor count for the month of August 2016 is 2,641. Year to date total is 22915.

Update on Terminal Project. The Design Team is continuing to find ways to cut costs as the lowest bid came in at \$5 million over budget.

Runway 10/28 pre-construction meeting was held September 26th. The notice to proceed date is October 17th. Barnhill Contracting won the bid and has worked for us in the past. This is a 120 day project with the possibility of a temporary shutdown if the weather should become too cold for asphalt application.

Mr. Whited will be recommending to City Council that the Stormwater Pipe Project name be changed to Aviation Fuel Farm Access Paving. This is due to the Army Corps of Engineers deeming the runoff is a stream.

Mr. Whited spoke to State Aviation about crack filling on the North GA Ramp. This will go on their lists of possible projects.

Mr. Whited wanted to update Commission on the Rates & Charges Study. At the next meeting, in the Management Notes Item, we will discuss the study, review recommendations and decide how the Commission would like to proceed. Once this is accomplished, we will be able to put on the Agenda and vote.
