#### 4.0 ANNOUNCEMENTS AND RECOGNITION

Mr. Donald Kunish, Tetra Tech, provided an update on the Hazard Mitigation with the aid of a PowerPoint presentation. Mr. Kunish stated at the February 6, 2017, work session, Council had reviewed four options, and selected Tier Four. Tetra Tech and City staff is prepared to begin the application process. Eligible homeowners will have the choice of one of three options: (1) Acquisition and demolition or buyout, (2) structure elevation or house raising, or (3) mitigation reconstruction or demolish and rebuild. Outreach will include mailing documents to all homeowners in a floodway or floodplain within the City. Over 600 properties have been identified. Homeowners will complete and return required supporting documentation. City staff and consultants will be available to assist homeowners preparing documents if requested. The City will complete and submit the Hazard Mitigation Grant Program application for the purpose of mitigating future flood risk. Mr. Kunish provided a timeline for upcoming events.

Council Member Hurst announced the 11th Annual Fayetteville Beautiful will take place April 2, 2017, and invited the public to join the event.

6.09 Adoption of Capital Project Ordinance 2017-45 to Appropriate the 2016-2017 Downtown Revitalization Grant from the North Carolina Department of Commerce, Rural Economic Development Division

Capital Project Ordinance 2017-45 appropriated \$94,340.00 awarded to the City by the North Carolina Department of Commerce, Rural Economic Development Division under its 2016-2017 Downtown Revitalization grant program. The funding will assist with expenses to install the pedestrian bridge and associated streetscape and landscaping along Ray Avenue at Cross Creek.

6.10 Adoption of Budget Ordinance Amendment 2017-17, Capital Project Ordinance Amendment 2017-23, Capital Project Ordinance 2017-44 and Capital Project Ordinance 2017-46 to Appropriate and Align Funding for Three Shawcroft Road Related Projects, and Bid Award for Shawcroft Road Temporary Culvert Repair

Budget Ordinance Amendment (BOA) 2017-17 and Capital Project Ordinance (CPO) 2017-46 appropriated \$238,700.00 from General Fund fund balance for this project. Awarding the contract for the construction of the Shawcroft Road temporary culvert to Sandy's Hauling, Roseboro, NC, the apparent lowest, responsible bidder, in the amount of \$217,000.00. In addition, on February 13, 2017, Council adopted CPO 2017-23 to appropriate \$1,190,818.00 for the Shawcroft restoration project, which included funding for the permanent restoration of the road and for the temporary access road at Cottage Way. Capital Project Ordinance Amendment (CPOA) 2017-33 and CPO 2017-44 are to separate the \$250,000.00 appropriated for the temporary access road into an additional CPO.

6.11 Transit Grant Subrecipient Agreements for Federal Transit Administration Section 5310, Enhanced Mobility of Seniors and Individuals with Disabilities

The City is the Designated Recipient for Federal Transit Administration (FTA) grant programs in the Fayetteville urbanized area. FTA has approved a grant under its Enhanced Mobility of Seniors and Individuals with Disabilities Program (Section 5310). The City/FAST submitted the application for this program based on the projects selected by FAMPO. The grant provides grant funding to Spring Lake, Mid-Carolina Council of Governments (MCCOG) and Cumberland Residential and Employment Services and Training Inc. (CREST). These will be grant sub-recipients to the City/FAST. Projects include a sidewalk accessibility project in Spring Lake, a taxi-voucher program within Cumberland County and vehicles and operating costs for CREST to provide door-to-door transit services for persons with disabilities to facilitate employment and vocational training.

#### 6.12 Selection of Independent Auditor

# 6.13 Adoption of Special Revenue Fund Project Ordinance 2017-6 to Appropriate Transit Grant NC-2016-014-00 for Fayetteville Urban Area Elderly and Disabled Projects for Sub-Recipients

The Federal Transit Administration (FTA) has awarded a \$621,699.00 grant to the City under its Section 5310 Enhanced Mobility of Seniors and Individuals with Disabilities Program. The projects funded under this grant are for the following sub-recipients: Town of Spring Lake, Mid-Carolina Council of Governments (MCCOG), and Cumberland Residential and Employment Services and Training, Inc. (CREST). The City receives \$21,277.00 in grant funding for administration of this grant. This Special Revenue Fund Project Ordinance (SRO 2017-6) will appropriate only the \$480,613.00 of federal funds for this grant as the \$141,086.00 of required local match is to be funded by the sub-recipients.

#### 7.0 REPORTS FROM BOARDS AND COMMISSIONS

#### 7.01 Annual Report from the Historic Resources Commission

Ms. Megan Maxwell, Historic Resources Commission Chair, presented the Historic Resources Commission Annual Report and stated the Fayetteville Historic Resources Commission's Statement of Purpose was to safeguard the heritage of the City of Fayetteville by preserving, in accordance with law, any property therein that embodies important elements of its cultural, social, economic, political, architectural history, and to promote the use and conservation of such property for the education, pleasure, and enrichment of the residents of the City, County, and State as a whole. The Fayetteville Historic Resources Commission (HRC), a quasi-judicial body, was established by City Council in accordance with North Carolina General Statutes. On November 9, 1999, the City of Fayetteville's HRC was approved as a Certified Local Government by the National Park Service upon the recommendation of the State Historic Preservation Officer. As a Certified Local Government, the City of Fayetteville is required to file an annual report on the activities of the HRC to ensure that the standards required are being met. Each year the HRC has received a favorable review from the State Historic Preservation Office. The Commission works closely with project proponents of historic landmarks or properties in the historic districts to ensure compliance with the Design Guidelines for Fayetteville's Historic Districts and Local Landmarks while meeting the needs of the citizens. One of the requirements of a CLG is mandated annual historic preservation training. In order to meet that standard, two commissioners and one City staff member have the option to attend the annual statewide historic preservation conference which covers topics ranging from the legal process to design review. Another program requirement for a CLG is an active public education program. Every year students ranging from elementary school students to college students engage in special tours of Fayetteville's historic districts to learn about local history and architecture. Many other local groups receive the same type of guided tours. The HRC is also involved in the review and recommendation of new properties for the National Register of Historic Places and the Fayetteville Historic Districts and Local Landmarks program. With jurisdiction on all exterior features in the historic districts and on local landmarks, the Commission is responsible for the review of new construction, demolition, and changes to existing structures, sites, and streetscapes.

Mr. Willie L. William, 1165 Sand Hill Road, Hope Mills, NC, spoke in favor of the proposed Shaw Heights annexation.

Mr. Jerry Reinoehl, 516 Deerpath Drive, Fayetteville, NC, spoke in favor of the proposed Shaw Heights annexation on the condition that the County bring the area into compliance with the County code standards, prior to any annexation.
