

If said bonds are issued a tax will be levied upon all taxable property in the City of Fayetteville for the payment of the principal of and the interest on said bonds.

For said election the regular registration books for elections in the County of Cumberland will be used and the registration books, process or records will continue to be opened for the registration of voters and the acceptance of registration applications from Monday to Friday, inclusive, of each week between the hours of 9:00 A.M. and 5:00 P.M., in the office of the county Board of Elections at the County Courthouse in Fayetteville; the registration books, process or records will be open continuously for the registration of voters and the acceptance of registration applications at all reasonable hours and times at the homes of the registrars or the special registration commissioners or wherever the registrars or special registration commissioners may be within the City; and the registrars will register any qualified citizen of the City at the addresses respectively, set forth below. Such registrars and such special registration commissioners may register all qualified citizens of the City and may take the registration applications and administer the oaths without regard to the precinct residence of the registrar, the special registration commissioner, or of the citizen applying for registration.

The registrars will not attend the polling places except on the date of election.

The registration books will be open to public inspection by any elector of the City between 9:00 A.M. and 5:00 P.M., on Tuesday of each week in the office of the County Board of Elections at the County Courthouse in Fayetteville, and each such Tuesday is Challenge Day.

The registrars, special registration commissioners and judges appointed by the County Board of Elections will act as registrars, special registration commissioners and judges, respectively;

Qualified voters who have voted in a County-wide or City-wide Primary or General Election since May, 1954, and have not moved their residence from one precinct to another, are registered under Cumberland County's permanent registration system.

The last day for new registration of those not now registered under Cumberland County's permanent registration system is Tuesday, March 1, 1960.

Qualified voters who have moved residence from one precinct or township to another and have not transferred their registration should contract the County Board of Elections at its office in the County Courthouse in Fayetteville, or any registrar in the City, and transfer their registration.

The last day for transferring registration is March 1, 1960.

Qualified voters who are not certain whether they are registered should contact the County Board of Elections at the office of said Board in Fayetteville mentioned above.
