Councilman Plummer introduced the following five ordinances authorizing bonds which were read:

AN ORDINANCE AUTHORIZING \$650,000
STREET IMPROVEMENT BONDS

BE IT ORDAINED by the City Council of the City of Fayetteville:

Section 1. That, pursuant to The Municipal Finance Act, 1921, as amended, the City of Fayetteville, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Street Improvement Bonds in an aggregate principal amount not exceeding \$650,000 for the purpose of providing funds for constructing or reconstructing the surface of streets in said City, including the contemporaneous construction or reconstruction of sidewalks, curbs, gutters, drains and grading and the acquisition of necessary land and rights of way, at least two-thirds of the cost of which improvements, exclusive of the cost of paving at street intersections, is to be specially assessed, such bonds to be in addition to the \$220,000 Street Improvement Bonds authorized by an ordinance passed on July 13, 1959.

Section 2. That a tax sufficient to pay the principal of and the interest on said bonds shall be annually levied and collected.

Section 3. That a statement of the debt of the City has been filed with the clerk and is open to public inspection.

Section 4. That this ordinance shall take effect when approved by the voters of the City at an election as provided in said Act.

AN ORDINANCE AUTHORIZING \$100,000
FIRE STATION BONDS

BE IT ORDAINED by the City Council of the City of Fayetteville:

Section 1. That, pursuant to The Municipal Finance Act, 1921, as amended, the City of Fayetteville, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Fire Station Bonds in an aggregate principal amount not exceeding \$100,000 for the purpose of providing funds, which any other available funds, for erecting and equipping fire stations in said City, including the acquisition of necessary land.

Section 2. That a tax sufficient to pay the principal of and the interest on said bonds shall be annually levied and collected.

Section 3. That a statement of the debt of the City has been filed with the clerk and is open to public inspection.

Section 4. That this ordinance shall take effect when approved by the voters of the City at an election as provided in said Act.

AN ORDINANCE AUTHORIZING \$750,000
WATER BONDS

BE IT ORDAINED by the City Council of the City of Fayetteville:

Section 1. That, pursuant to The Municipal Finance Act, 1921, as amended,

the City of Fayetteville, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Water Bonds in an aggregate principal amount not exceeding \$750,000 for the purpose of providing funds, with any other available funds, for enlarging and extending the waterworks system of said City, including the acquisition of additional water storage, treatment and distribution facilities and the acquisition of necessary land, rights of way and equipment.

Section 2. That a tax sufficient to pay the principal of and the interest on said bonds shall be annually levied and collected.

Section 3. That a statement of the debt of the City has been filed with the clerk and is open to public inspection.

Section 4. That this ordinance shall take effect when approved by the voters of the City at an election as provided in said Act.

AN ORDINANCE AUTHORIZING \$750,000
SANITARY SEWER BONDS

BE IT ORDAINED by the City Council of the City of Fayetteville:

Section 1. That, pursuant to The Municipal Finance Act, 1921, as amended, the City of Fayetteville, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Sanitary Sewer Bonds in an aggregate principal amount not exceeding \$750,000 for the purpose of providing funds, with any other available funds, for enlarging and extending the sanitary sewer system of said City, including the acquisition and construction of additional sewage collection and outfall and other disposal facilities and the acquisition of necessary land, rights of way and equipment.

Section 2. That a tax sufficient to pay the principal of and the interest on said bonds shall be annually levied and collected.

Section 3. That a statement of the debt of the City has been filed with the clerk and is open to public inspection.

Section 4. That this ordinance shall take effect when approved by the voters of the City at an election as provided in said Act.

AN ORDINANCE AUTHORIZING \$250,000
RECREATION FACILITIES BONDS

BE IT ORDAINED by the City Council of the City of Fayetteville:

Section 1. That, pursuant to The Municipal Finance Act, 1921, as amended, and the Recreation Enabling Law, as amended, the City of Fayetteville, North Carolina, is hereby authorized to contract a debt, in addition to any and all other debt which said City may now or hereafter have power or authority to contract, and in evidence thereof to issue Recreation Facilities Bonds in an aggregate principal amount not exceeding \$250,000 for the purpose of providing funds, with any other available funds, for constructing and equipping recreation facilities and all buildings and structures necessary or useful in connection therewith, including the acquisition of land therefor.

Section 2. That a tax sufficient to pay the principal of and the interest on said bonds shall be annually levied and collected.

Section 3. That a statement of the debt of the City has been filed with the clerk and is open to public inspection.

Section 4. That this ordinance shall take effect when approved by the voters of the City at an election as provided in said laws.

Thereupon Councilman Plummer introduced the following resolution which was read:

WHEREAS, there have been introduced and there are now pending before the City Council five ordinances authorizing bonds of the City of Fayetteville; now, therefore,

BE IT RESOLVED by the City Council of the City of Fayetteville that the City Clerk and Treasurer be and she is hereby designated as the officer who should make and file with herself as clerk the sworn statement of the indebtedness and
